As a Fire Department, we provide reliable public services in a safe, efficient, and effective manner using all available resources and opportunities.

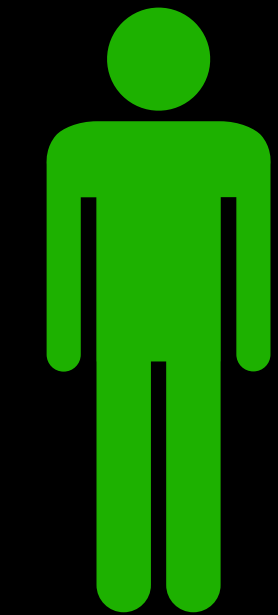
CORE BELIEF

Prognosis for Cardiac Arrest Survivors

Survival after a [cardiac arrest](#) is dependent on many factors.

Factors before cardiac arrest:

- Age
- Ethnicity
- Poor health including diabetes, cancer, infection, kidney disease and stroke

Factors during cardiac arrest:

- Time between collapse and start of CPR/defibrillation
- Quality of CPR/defibrillation
- Whether survivor had neurological function during or immediately after CPR
