Council Member Brekhus requested a staff presentation.

Michael Mischel, City of Reno Development Services Engineering Manager, stated he does not have a formal presentation for this staff report but he considers it a cleanup item. This portion of Coleman Drive was offered to the City of Reno in 1996 and should have been accepted decades ago.

Council Member Brekhus stated it is highly unusual for us to have a street that hasn't been accepted and she thinks there was a little bit of history to this. She asked how

this came to staff's attention.

Mr. Mischel stated it came to his attention by NV Energy. NV Energy asked that we formally accept this portion of Coleman Drive. He confirmed that he did not hold any neighborhood meetings or inform any residents in the area of this.

Council Member Brekhus stated she recalls there was a series of special use permits associated with the Highland Reservoir and there might have been some history. This should be advertised to the neighbors and go to the Neighborhood Advisory Board (NAB). The acceptance of this street could allow the subdivision or parcel map of some large lot development located at the extension of Putnam Drive. The city has likewise not accepted Putnam Drive in that time and she does not recall the circumstances. She asked if anyone has reached out to the Development Services division about subdividing some of the larger lots.

Mr. Mischel replied not to his knowledge.

Council Member Brekhus stated accepting this road and then a subdivision map coming in the future is piecemeal development and wrong. Without any advertisement to the neighbors and without going to the NAB, she is having a hard time doing this as cleanup. At a minimum, Council should ask for some history on why the city did not accept the roads in the first place.

Discussion on first motion:

Council Member Reese stated he will not support the motion. Politicizing acceptances of streets is unnecessary. He agreed with staff that it is a routine thing and all residents desire to know that the roads they travel are owned by an entity that cares for and maintains them. He does not think it presents an opportunity for any development that would not otherwise occur.

Council Member Taylor stated that as the representative of this Ward she will not be supporting the motion.

Motion failed and a second motion was made.

Council Member Ebert stated her support of the first motion was not to say she would not support accepting these roads but she does not see any harm in pushing it back one month and getting more community feedback. She does not think that is a politicized move. Any time we get community engagement it is important for the citizens.

Council Member Reese stated he would support the original motion. There is a current trend of violence towards people in this country and all across the world that should not be discounted. The organization uses the funds for Jewish life in Nevada but they feel kinship across boundaries in a way that we do not as non-Jewish people. Whatever they are doing with it is worthwhile to support their cause and an organization does not need to be micromanaged in the way that is suggested.

Council Member Duerr stated she would support the original motion. Generally the donated dollars are so small they are going to use them locally.

Council Member Ebert stated she is comfortable leaving the motion as is.

Discussion on the motion:

Council Member Brekhus stated that she unfortunately will not support this. It is very consistent for us to target within our organization where the money goes. Because this one states the funds could support Jewish life in Israel and around the world, she cannot support Reno money going to Israel related activities. Having said that, she stated that she does not support antisemitic views, speech, or action.
