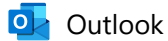

Dear City of Reno leaders:

I object to penalizing citizens by increasing the Appeal process by 365% to \$500.

What is an Appeal for anyway?

It is the Citizen's only way to demand that our elected officials step-in and weigh-in by voting down or amending decisions by either the PLANNING STAFF and / or well-meaning but non-professional, non elected, volunteers (Planning Commissioners).

If the Planning Dept. does a great job (and they usually do) in communicating the issues of the project, I think the City should have to bear the expense of the appeal.

If developers do a great job in communicating their plans to the community, then their submittals would not likely be appealed.

It is my opinion that the developers should be charged a flat fee for Appeals of \$5,000 on submittal. (I believe this is the cost to the City for an Appeal.)

If there are no appeals, then the \$5,000 is refunded to the developer.

On the other hand if the developers fail to communicate their plan and build consensus among the community, then they should have to pay for the Appeal process of \$5,000 EACH.

To me the \$500 is a punitive action - against any citizen with a problem with what developers want to build in this City.

It feels like this increase was suggested by the developers as a way of not having to deal with the public airing of their project "issues".

Let the citizens continue to pay the existing \$100 as a formality.

**PUBLIC COMMENT RE: CREATING LIVE ENTERTAINMENT AREAS,
MEETING DATE MARCH 25, 2025**

I am a working resident of downtown and since this meeting is being held during business hours, I cannot attend to voice my opposition and am submitting it via email to public comment, for the record.

I am in opposition to creating live entertainment areas. I have a copy of the draft Live Entertainment Zoning Code - (ver. 3 11 25) .

I have seen many references to residents asking for C-scale to be added as a noise standard. The ask by residents was 60 dBc, modeled after Orlando's mixed-use district, and extensive research was presented to support that along with an explanation of how decibel increase actually works. A 10 dB increase in sound level is perceived as approximately a doubling of loudness, for example, 70 dBc is two times louder than 60 dBc and 80 dBc is four times louder than 60 dBc.

The 80 dBc referenced in the draft is actually four times louder than the resident ask of 60 dBc!

There is no mention of outdoor live entertainment noise limits from 10:00 A.M. to 11:00 P.M. Past year's Bass Camp readings were up to 110 dBc, which is considered extremely dangerous and only should be exposed to for 1/2 hour or less.

There is no mention of lighting/strobe lights. Again referencing the Bass Camp event last year, its massive light pollution, and in the exact same spot where proposed festival grounds are.

There is no mention of soundproofing or noise mitigation by the bars/clubs.

There is no mention of the current live entertainment requirement of requiring bar/club windows and doors be kept closed after 9:00 P.M.

There is no mention of enforcement. How is the city going to enforce anything? Supplemental RPD has been cut from downtown on the weekends, RPD considers nuisances a third-tier, if at all, response, and Reno Direct just closes cases and reroutes lodgings to public comment.

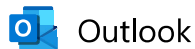
There is no mention of days of the week the draft zoning pertains to. I am a working resident of downtown and am very concerned, is the proposal seven days a week?

The draft outdoor live entertainment time is 10:00 A.M. to 11:00 P.M., then indoor live entertainment time is 11:00 P.M. to 6:00 A.M. the next day, that's four hours a day with no "live entertainment," when are residents supposed to sleep?

At the February 19th Planning Commission, one of the city planners stated the city was recommending new applications of live

entertainment be granted with an end time of 3:00 A.M. That is what Two One Nine (formerly Eden) currently has and what was granted to 1Up on the 19th of February. At least with a 3:00 end time, it minimizes the intersection of clubbers with residents and churchgoers. I experienced this myself one morning around 5:30, walking a dog and coming across police activity where a patron had shot from Eden into the parking lot across the street. And, yes, the parking lot at Saint Thomas Aquinas Cathedral, directly across the street from downtown bars/clubs, starts filling up around 6:00 A.M. Sunday mornings. There was yet another incident bringing out five police cars and an ambulance in the early morning hours, Sunday, March 23, 2025, corner of West and 2nd.

Again, for the record, I am a downtown Reno resident and I am opposed to creating live entertainment areas in Reno. Discussing the draft regulations that the city prepared and attached to a March 11, 2025 email from Angela Fuss is entirely premature and assumes that I am willing to accept the concept of live entertainment areas. The end result of the City's effort will add to the nuisance environment that already exists in downtown Reno, especially as it will add to the existing nuisances from bars and nightclubs, as well as the J Resort's proposed outdoor event grounds.

For the record, I am a downtown resident and was awoken by booming bass noise early this morning, Sunday, March 23, 2025 in the 2nd Street corridor. I went out to my balcony in an attempt to discern where the noise was coming from. There was yet another incident involving police and ambulance at Two One Nine (formerly Eden), as you can see in the photo, five police cars and an ambulance. The photo was taken at 5:42 A.M., Sunday, March 23, 2025, at the corner of West and 2nd, the parking lot of Two One Nine (formerly Eden).

RE: Accessory Dwelling Unit (ADU) Comments

I have been attending the Neighborhood Advisory Board meetings over the past month. I would like to build an ADU but have some concerns over the proposed plan. I did not want to wait until the proposed ADU regulations go before the Council for a vote because I feel that often decisions are made before the final vote and the meeting doesn't leave time for meaningful discussion. I have listed my concerns below and hope that you will take them into consideration for your final decision.

My frustration with the proposed ADU regulations are because the city of Reno has blocked my every attempt at utilizing my property to its full potential.

Reno Option for Additional Structures on 6,000 sq. ft. parcel	RENO	Reasons
SF 8 Zoning	NO	Can't build a second structure
Attached Garage	NO	Current layout of existing structure does not allow a way this would be viable.
Detached Garage	NO	Could only be 50% the size of house making it a 300 sq. ft. Garage?
ADU	NO	I have a 6,000 sq. ft. lot not the proposed 9,000 sq. ft. lot
Cottage	Maybe	Reno Planner of the day thinks MAYBE (?) could build the primary in front of existing and use existing as cottage if stove is removed. A lot of Maybes.

1. If the goal is to infill underutilized parcels in central Reno, then why does the proposed ADU regulations not allow the current/existing residence be considered the ADU and the new residence be primary? My current multi-generational home is 597 sq. ft. situated at the rear of the 6,000 sq. parcel leaving 90% of the parcel unusable. I would like to build a 950 sq. ft. multigenerational home in the front. But the proposed regulations do not allow this because they are rigid about ADUs being built behind current structures. What is the logic in this? (I bought this home for my mother and when she passed my disabled brother lived there for 16 years and when he passed my daughter-in-law and grandkids currently live there.)
2. I would like to build a 950 sq. ft. in fill project that would be slightly less than the 50% of the 1,200 primary requirement. Why no individual considerations for very old odd existing parcels.
3. The explanation given for the 9,000 sq. ft. parcel size requirement does not make any sense when the following (Item 5) are the current size requirements in other areas of the country. If the parcel has room for proper setbacks given the current footprint of existing structures what is the motivation for this requirement?
4. This is not my area of expertise but I did find some information about successful ADU regulations in other jurisdictions.

Washoe County – No parcel size requirement.

Portland OR – Couldn't find parcel size requirements and I believe they have abandoned parking requirements and now regulate short-term rentals because of the detrimental impact to permanent housing and homelessness that short-term housing had created. AB&B now pay the city fees.

Seattle WA - 3,000 sq. ft.

Mesa AZ - Anywhere Single Family is allowed

Austin TX - 5,700 sq. ft. parcel

Denver CO - 3,000 sq. parcel

North Carolina – Couldn't find a lot size requirement just setbacks and no parking requirements. **But they do have a great online fee calculator so people know up front whether or not it's a viable project.**

Minnesota – Couldn't find lot size requirement.

5. Why are you not regulating short-term Air B&Bs? There are currently 538 AB&Bs in Reno and over 300 VRBOs available on the internet in Reno. We are losing revenue on this unregulated asset while hotels who pay room tax struggle. What is the motivation to let these short-term rentals hurt local businesses, contribute to the homeless epidemic and leave money on the table when Reno is already in the red? These short-term rentals could help fund our homeless crisis.
6. How many more times will we waste manpower, money, and energy placating to the residents of old southwest Newlands area. Many communities just carve out historical neighborhoods from the ADU regulations. It seems like an easy solution. There are many communities across the country who have successfully implemented ADUs including our own Washoe County. The blueprint already exists but somehow, we want illogical limitations that will be challenged in the future wasting more time, money, and energy.

ADUs are a great tool in our toolbox for increased revenue and permanent housing if done correctly and not allowing them to become AB&Bs.

Thank you for your time and consideration in this matter and I look forward to the next meeting on this subject. I would also love to meet in person with any of you that would have a few minutes to go over any questions or concerns.
