




NEVADA STATE LIQUOR LICENSE APPLICATION

Describe, step by step, the nature of your business and procedure to produce liquor in Nevada

Adventurous Ales, LLC is a Brewer that solely manufactures beer for distribution. Adventurous Ales follows standard brewing practices and procedures to produce beer in Nevada. Specifically, our process involves the following key steps:

1. Permits and Licenses: Adventurous Ales has obtained the appropriate permits and license from the TTB and the NV Department of Taxation.
2. Acquiring Raw Materials: Adventurous Ales procures malted grains, hops, and yeast from local vendors as well as specialty ingredients such as spices and fruits for our specialty beers.
3. Milling and Mashing: The malted grains are milled to break them down, and then are mixed with hot water during which the enzymes in the grains convert starches into fermentable sugars.
4. Boiling and Hopping: After mashing, the wort is transferred to a kettle and boiled. Hops are added at various stages during the boil to impart bitterness, flavor, and aroma to the beer.
5. Cooling and Fermentation: Once boiling is complete, the wort is rapidly cooled to the temp suitable for fermentation. Yeast is added, which consumes the sugars in the wort, producing alcohol.
6. Maturation: After fermentation, the beer is left to mature for a period of time. This allows the flavors to develop and the remaining yeast to settle.
7. Packaging: Once the beer has matured, it is ready for packaging. Canning and kegging occurs on site.
8. Distribution: Packaged beer is sold to our distributor. Adventurous Ales does not conduct any D2C sales
