Dear Members of the City of Reno Financial Advisory Board,

As a professional closely following the issues surrounding past abuses of the City of Reno's Travel Reimbursement Policy 306, particularly by Mayor Schieve, Council Members Devon Reese, and Miguel Martinez, I strongly urge the Board to reconsider who serves as the approving authority for council travel expenses.

Evidence has shown that Mayor Schieve not only violated Policy 306 but also engaged in excessive spending. Given her close ties with certain council members, allowing her to oversee and approve council travel creates a clear conflict of interest and compromises accountability.

To ensure greater transparency and financial oversight, I propose:

1. Replacing the Mayor as the approving authority with an independent body or a special appointee drawn from the constituency.
2. Appointing an external auditor in addition to the internal auditing team. While the internal auditors have done commendable work, they are still city employees, making them potentially susceptible to pressure or influence from leadership. An external auditor would strengthen internal controls and ensure unbiased financial oversight.

I appreciate the Board's consideration of these necessary reforms and would welcome further discussion on this matter.
