Hello,

I am a resident of South Reno residing in the Virginia Foothills. I have lived in this area for the past 8 years.

Wild Horses have roamed these streets for as long as I can recall. Today, with the enormous residential growth, the amount of horses hit and killed in the streets has increased. I am a previous volunteer for Wild Horse Connection , a volunteer organization, and this organization works day and night, in all weather conditions, moving horses back up into the foothills. There is only so much they can do to help solve this problem without the City of Reno assisting with the cost of the fencing. This topic has long been a discussion point and it's time to take action and assist with the funding. Fencing will keep these horses up in the foothills away from traffic and reduce the number of accidents. When a horse is killed, it takes Public Safety resources away from human related crimes, involves Public Works and resources to dispose of the animal. The human costs are potential bodily injury, insurance costs, car repairs or replacement.

The traffic has already gotten much worse in this area, with another 3500 homes due to be built. The horses need some protection from mans progress and keep them safe up on the range where they can access water and be kept out of the residential areas. People still speed down Veterans and Gieger to no avail and the problem will continue to get worse if fencing is not installed.

Good morning, Members of the Reno City Council.

I am a Carson City resident, but I travel to and from UNR daily, in fact 4 times a day. I drive alongside the Washoe Lake and always admire the multi-colored herds of wild horses grazing alongside its' shores. I drive along the freeway at 70 mph with the assurance that I will not suddenly encounter a horse standing in the road, sometimes in very treacherous winter conditions. I know this because the freeway is fenced.

I have, however, been driving in the suburbs of South Reno and to my disbelief have seen wild horses standing in large condominium complexes there. I know horses very well having spent many years owning and riding them. I have myself ridden alongside roads and have experienced firsthand that many motorists are clueless about slowing down for horses – and these were not wild ones.

I am also a person who has lost a sister in a non-horse related traffic death. I know the pain that comes from this tragedy, and I know that no matter how much time passes, the loss is still palpable, and the pain will never go away.

Reno's current growth is astounding. New complexes, shops and houses are being built every day, often on range land that the Virginia wild horses have roamed for generations. People are moving to Reno to enjoy the magnificent mountain views, the wildlife and all the amenities that a fast-growing city can offer. More taxpayers mean more revenue for the city, so it is incumbent on the city to ensure the safety of its' residents and minimize expensive lawsuits.

Wild horses deserve to live here safely as well. They are, as the 1971 Free Roaming Wild Horse and Burro Act states "living symbols of the historic and pioneer spirit of the West"

I appeal to the Council to set aside these funds to safely fence the horses in their range and prevent needless deaths to both parties. After all, what price can be put on a life?

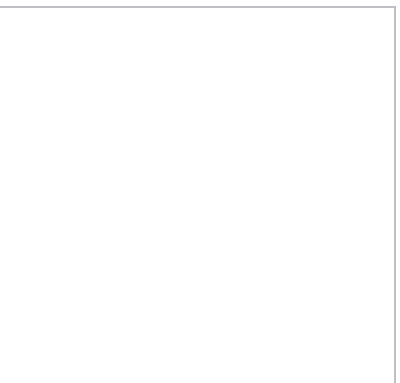

My name is Kellie Hansen and I have lived off of Toll Road in South Reno for over 30 years where wild horses commonly travel down to enter into south Reno neighborhoods.I am writing to you today with a heavy heart but also with a deep sense of urgency regarding the safety of both our community and the wild horses that roam the Virginia Range. Additional funding for fencing and fencing projects are desperately needed to keep everyone safe on the Reno and throughout the Washoe County. It is my fervent hope that through your esteemed council, we can enact measures to protect these majestic creatures and prevent further tragic incidents such as the one I experienced firsthand.In March of 2018, while driving home from a friend's house late at night, a group of wild horses suddenly darted onto the road in front of me. I swerved to avoid hitting them, but ended up driving my car into a ditch, resulting in a devastating accident that left me hospitalized. The trauma and pain inflicted upon me that night are indescribable, and I wouldn't wish such an ordeal upon anyone. My family didn't know where I was until they found my car covered in blood, after I was transported to the hospital. Not only did I suffer physically from the accident, but the emotional toll has been equally profound for me and my family as I am the primary income provider. I have been diagnosed with PTSD, haunted by the memories of that fateful night and the senseless suffering I witnessed among the wild horses. I have included pictures of my accident to reference. As a former volunteer with the Wild Horse Connection, I have seen firsthand the heartbreaking aftermath of collisions between vehicles and these beautiful creatures.Too often, I have stood by helplessly as injured or deceased horses lay strewn across our roadways, waiting for authorities to arrive and provide assistance. Some were lucky enough to receive prompt medical attention, while others were not so fortunate, succumbing to their injuries before help could arrive. The toll on both human and animal life is simply unacceptable. Additional funding for fencing is necessary to keep both horses and the community safe. That is why I implore you, esteemed members of the council, to consider the urgent need for fencing to safeguard our roads and highways from wandering wild horses. By establishing sensible barriers, we can prevent further tragedies, protect our community members from harm, and preserve the integrity of our natural habitats.I understand that funding such initiatives may pose a challenge, but the cost of inaction far outweighs the financial investment required. The lives and well-being of both humans and animals are at stake, and we cannot afford to delay any longer.Please, let us come together as a community to enact meaningful change and ensure a safer, brighter future for all. The wild horses depend on us, and we owe it to them, and to ourselves, to act decisively.

To the Honorable Mayor Hillary Schieve and Reno City Councilmembers I write this in support of your allocating all of the needed funds to construct the Wild Mustang fencing project along the east side of south Reno. This project is long overdue, and every day the project remains incomplete it puts the public at risk. This matter is scheduled to be considered by the council at your meeting on Wednesday June 12, it will be agenda item D.2 I have more than a passing knowledge of the importance of this project. I am with one of the non-government organizations that comes in to pick up the pieces after there is a catastrophic interface between a vehicle and the Wild Mustangs. Media reports suggest that there have more than 40\* such incidents in the area this last fall/ winter, additionally there have been 43 incidents inside the Reno city limits since 2019 with 11 of these occurring in 2023 alone. Virtually all of these collisions have resulted in vehicles being badly damaged or totaled (would you like to see some of the pictures?). In most cases, the Mustangs who were hit have died a horrific death at the scene or a few days later. At this point, it would not be a stretch to believe that the cost to the public (vehicle repairs etc.) is approaching \$800,000.00 for the last 12 months or so. This does not count the

costs to vehicle occupants in terms of recovery and medical bills.. The council should consider that for the most part, all of the injuries to people, the cruel deaths of the Mustangs and property loss is preventable. Fencing placed between the urban areas and the Virginia Range would truly move the needle towards improving the situation and protecting the public. This would include constructing fencing behind the Damonte, Curti and Carmella Subdivisions, as well as along Toll and Veteran's Roads. So, I won't comment on the fact that over 15,000 homes have been built in the area where Mustangs Walk. This having been done without any true consideration for their presence, nor the fact that this is a people problem (from city planning to development to lifestyle) and not the fault of the Mustangs. I will however once again urge you to allocate the needed funds to build this critical fencing project for the protection of both people and the Mustangs.
