

**RESOLUTION DONATING COUNCIL DISCRETIONARY FUNDS TO NORTHERN NEVADA HOPES WHICH IS DEDICATED TO BUILDING A HEALTHIER COMMUNITY BY PROVIDING COORDINATED CARE AND SUPPORT FOR INDIVIDUAL AND FAMILY WELLNESS BY OFFERING HEALTHCARE MODELS THAT ARE AIMED TO REDUCE BARRIERS TO CARE IN THE AMOUNT OF \$5,000 (GENERAL FUND).**

**WHEREAS**, the City of Reno may donate funds in accordance with NRS 268.028, entitled “Expenditure of public money; grant of public money and donation of certain property to certain nonprofit organizations or governmental entities” when such expenditure provides a substantial benefit to the inhabitants of the City; and,

**WHEREAS**, Northern Nevada HOPES, a 501(c)3 nonprofit organization, offers a variety of healthcare services such as adult and pediatric primary care, chronic disease management, wellness and nutrition, behavioral health counseling, substance use counseling, case management, a pharmacy, and more; and,

**WHEREAS**, Northern Nevada HOPES offers resources such as Teen Health Resources, LGBTQ support, Medication-Assisted Treatment, housing resources, and Change Point, which is a legal syringe service that aims to keep syringes off the street and offers drug testing; and,

**WHEREAS**, Northern Nevada HOPES is comprised of a team of licensed family medicine, infectious disease, pediatric and psychiatric doctors and nurse practitioners as well as 30 bilingual medical assistants and technicians dedicated to helping underserved medical community members; and,

**NOW, THEREFORE BE IT RESOLVED** that the City of Reno approves the Council donation from Councilmember Taylor in the sum of Five Thousand Dollars (\$5,000) to Northern Nevada HOPES which is dedicated to building a healthier community by providing coordinated care and support for individual and family wellness and,

**BE IT FURTHER RESOLVED**, that should the above donation or any portion thereof not be used for the purpose as set forth in this Resolution, any unused funds shall be returned to the City of Reno.
