### **Background:**

Pursuant to Reno Municipal Code (RMC) 2.08.030, the RPC is appointed by Council and shall consist of nine voting members who reside within the City of Reno. Employees of the City of Reno are not eligible for membership. In the event of a vacancy on the RPC, RMC 2.08.060

provides that the city shall appoint a suitable person to fill such a vacancy.
