**RESOLUTION ESTABLISHING THE STORMWATER
ENTERPRISE FUND PER NEVADA REVISED STATUTES
§354.612 AND APPROVAL OF THE FUND POLICY FOR
THE STORMWATER ENTERPRISE FUND**

WHEREAS, NRS §354.612 provides for the establishment of funds by local government,
and;

WHEREAS, the purpose of the Stormwater Enterprise Fund is
to create a fund pursuant to NRS §354.612, for an operations fund for user charges received which
are related to stormwater collection, treatment and disposal;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF RENO DOES
RESOLVE:**

Section 1. Funds for the Stormwater Enterprise Fund include user charges for the
operation and maintenance of the City's stormwater collection, treatment, and disposal system.

Section 2. All interest generated by funds invested in the Stormwater Enterprise Fund.

Section 3. The expenditure of funds from the Stormwater Enterprise Fund shall be for
the operation, maintenance, and upgrade of the stormwater collection and treatment systems
necessary to support current system users and to provide for the adequate growth of the system in
response to any increase in use of the system.

Section 4. Any fund balance in the Stormwater Enterprise Fund shall remain in the fund
and be used for the purposes specified above and shall be considered reasonable and necessary to
carry out the purpose of the fund.

Section 5. The City of Reno, Nevada does hereby establish a Stormwater Enterprise Fund.

Section 6. All provisions of this resolution shall become effective immediately upon
passage.
