I am receipt of a mailer regarding the above LDC24-00029 (RENO AXE) regarding an appeal of the planning commission as I have residential property within 750 feet.

My concern, as written, the conditional use permit if granted would essentially allow for 24-hour use, more specifically indoor "Live Entertainment" activities from 11:00pm to 10:00am.

Although this is a downtown area, and there are uses that 24 hours, I am against the approval of "Live Entertainment" from 11:00pm to 10:00am.

However, I would support indoor "Live Entertainment" from 11:00pm to 3:00am with certain restrictions on the level (measured in decibels - i.e. db's) allowed to be emitted and measured outside the premises.

Extracting from the Planning & Development Code

Live Entertainment A facility that provides live performances and entertainment, including but not limited to singing, dancing, floor show and musical entertainment, subordinate to the primary commercial use of the establishment. Live entertainment does not include any use defined under Adult Business.
