**Summary:**

The Parks and Recreation Department was contacted regarding a community-driven initiative to enhance CPR training resources within the City of Reno through mannequin breast vests. Amelia Grieve, a local Girl Scout and City of Reno lifeguard pursuing her Gold Award, developed this CPR training enhancement product designed to improve hands-on learning and accessibility in emergency response education. The total value of the five (5) CPR units are \$1,772.00.

**Background:**

Amelia Grieve, a local Girl Scout and City of Reno lifeguard pursuing her Gold Award, developed these CPR training devices and is donating five (5) of them to the City of Reno Parks and Recreation Department. Grieve made the breast vests for her Girl Scout Gold Award (similar to an Eagle Scout award). They are vests that can go over the CPR mannequins to simulate CPR with breast implants to train lifeguards on how to do resuscitation on women. It is widely known that people and lifesavers are uncomfortable doing CPR on women and hesitate to save them. Grieve hopes to alleviate some of the stigma around doing CPR on people with breasts.

**Discussion:**

The vests are made from wet suit material with the breast implants sewn in. Amelia fitted the vests with swimsuits so that lifeguards and the general public can practice removing swimsuits or shirts in the event that an AED is needed to be used. She recently made a presentation to the Recreation and Parks Commission on 02/25/25 meeting who recommend acceptance of the donation. The five (5) vests have already been used during public CPR classes, life guarding classes, and monthly lifeguard in-service trainings.
