The Webb Data Center's energy footprint is equivalent to about ~4,000 homes.

AI, data center load could drive 'extraordinary' rise in US electricity bills: Bain analyst

Utility revenue requirements to serve growing data center electricity demand could increase customer bills by 1% annually through 2032, according to Bain & Company.

Tax Abatements Overview

Data Center Tax Abatement ([NRS 360.754](#)):

A partial abatement from personal property tax and sales and use tax are available to data center companies that locate or expand their business in Nevada. Abatements apply to colocated businesses of the data center.

A company and co-located tenants who intend to locate or expand a data center in Nevada and meets certain requirements may qualify for:

- Personal property tax abatement of 75% of the tax due for 10 or 20 years
- Sales and use tax abatement reducing the rate to 2% for 10 or 20 years

PROCESS

- Reno staff created a new data center use category and where the use could be allowed under ALDC 18.03.205, all without public notice, hearing, or input. Staff then brought an after-the-fact code change.
- Concerns with process
 - NRS 278.250 and 278.260



FINDINGS

- The Webb Data Center is inconsistent Reno Master Plan
- Compliance issues with Title 18
- Does not provide a safe environment for residents
- Finding issues associated with the Conditional Use Permit (CUP)



OUR ASKS

- Deny the Webb Data Center CUP
- Request a briefing from the Public Utilities Commission of Nevada (PUCN) and Truckee Meadows Water Authority (TMWA)
- Hold a publicly noticed hearing focusing on whether and where data centers should be allowed
- Revise the ordinance pertaining to data centers within city limits
- Evaluate the possibility of establishing regional guidance for data centers
