I am writing to voice my strong **opposition** to the request by Jacobs Entertainment for the City of Reno to abandon part of Bell Street and contiguous alleyways. It is impossible for City Council to make the required finding that the public will not be materially injured by this request. The current and future occupation and use of Bethel AME Church at 220 Bell Street would be greatly injured by these abandonments, with not just the loss of 21 unmetered public parking spots but also the loss of any route of ingress and egress to the church building other than West Second Street. Not only does another congregation currently use this building, but Bethel AME has long been considering transforming the church into a museum or cultural center, and needs all of those spaces and routes to remain intact as public rights-of-way and public space in order to ensure that they will be able to continue to extend and expand its use by the community. The Bethel AME Church is listed in the National Register of Historic Places and is the oldest surviving African American church in Nevada, and these abandonment requests are unnecessary and injurious. Dear Mayor Schieve and Esteemed Members of the City Council of Reno, Nevada:

I am writing on behalf of Bethel AME Church and the Bethel Housing Development Corporation to formally reject Jacobs Entertainment, Inc.'s application for the City to abandon part of Bell Street and the connected alleyways. We adamantly uphold our right to access these alleyways and the entire length of Bell Street. We do not waive our rights. We urge City Hall to consider our concerns in this matter as Jacobs Entertainment's request is materially injurious to our current tenant and our plans for 220 Bell Street:

**We reject the application for several reasons:**

- 1) The property at 220 Bell Street (APN #011-021-05) is not abandoned.
- 2) A longstanding tenant currently occupies the property full-time and requires all parking spaces employed.
- 3) Bethel AME Church has concrete plans to convert the property into a Black Museum and future Cultural Center, which will serve as a valuable community resource. The parking on Bell Street is limited as it is. Jacobs Entertainment's application will decrease parking for 220 Bell Street.
- 4) Our tenant's church is already constrained by limited parking availability. Granting Jacobs Entertainment permission to close off part of the street would exacerbate parking issues, impede our access to 220 Bell Street, and hinder ingress and egress facilitated by the alleyways. Should there be a need for emergency vehicles, access will be hindered and might impede life-saving measures.
- 5) 220 Bell Street holds national significance as a building listed in the National Register of Historic Places, and its preservation is paramount to our organization. We have no intention of selling or relocating this property.
- 6) We vehemently oppose any encroachment upon our property or diminishment of its historic significance. Jacobs Entertainment has requested to purchase or relocate our property for years.
- 7) Bethel AME Church holds a unique place in Nevada's history as the oldest surviving African American church in the entire state, not just Northern Nevada. It is incumbent

upon us to safeguard and preserve our African American heritage. Please do not allow Jacobs Entertainment to disregard or dismiss the heritage represented by our property that has been present in our community since 1907.

In light of these considerations, we respectfully urge the City Council to reject Jacobs Entertainment's application and to uphold our rights and interests in this matter. We appreciate your attention to this important issue and trust that you will give due consideration to our concerns.

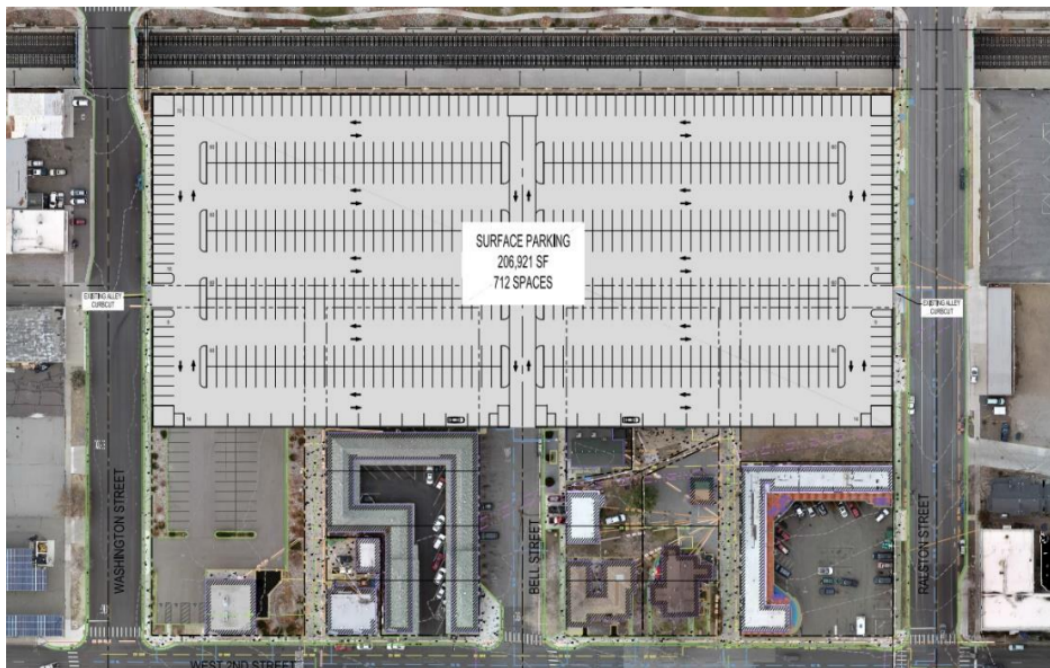

In a January 24, 2024 letter, in answer to a question from Development Services regarding the Applicant's future use of the block which includes the current requested Abandonment area, the Applicant answered:

**Response:** The Owner intends to utilize this block for parking and additional event space for the existing Glow Plaza Festival grounds. A rendering is included below.



In the Applicant's letter of December 27, 2021, submitted as part of a CUP application package for the Glow Plaza, the Applicant submitted the following response to address the requirement that the project would mitigate traffic impacts.

**Response:** The proposed Glow Plaza is anticipated to host several events throughout the year, primarily during nights and weekends outside of peak traffic hours. The Glow Plaza contain 200 parking spaces, and another three parking lots provide an additional 319 parking spaces within 1,040 feet or closer to the festival grounds. As necessary, approximately 136 parking spaces may be made available at the nearby Gold Dust West, which is held in common ownership with the festival grounds. Indeed, a parking study identified that the total parking supply in the immediate project area could accommodate an event up to approximately 3,500 attendees at this site. .

Further, in the same 2021 CUP application package, consultant Headway Transportation provided the following table for the Glow Plaza.

**Table 2. Available Parking Supply**

Parking Lot	Available Parking Supply	Dedicated Parking	Approximate Distance from Project (ft.)

B	200	Yes	0

**NOTE:** In 2021, none of the A, B, C, or D parking lots included the 712 new parking spaces now revealed in the Applicant's current Abandonment request.

So, in 2021, the applicant explained that there were 519 existing and available parking spaces and, with support from their transportation consultant, the applicant was able to make the statement "*total parking supply in the immediate project area could accommodate an event up to approximately 3,500 attendees at this site*". In other words, the Applicant asserted that there were ample existing parking spaces (even more if one also counted on-street parking spaces and 136 spaces at the Gold Dust West casino) to satisfy the CUP requirements for the Glow Plaza.

And yet, since the Glow Plaza CUP was approved in 2022, the Applicant will have added 712 more parking spaces. Of these, approximately 500 have already been built and approximately 200 more will be added if the current Abandonment request is granted. Said simply, the Applicant erred egregiously in the CUP Application (712 spaces over the 519 presented = **137% variance**) and now seeks to compound this error.

In an RGJ opinion article from January 11 , 2022, CM Duerr pointed out that: "*Reno has the dubious distinction of being one of the fastest-warming U.S. cities over the last 50 years....*"

With the stated plans the Applicant has for this current Abandonment request, there would be yet more parking blacktop added to an already over-heated Downtown Reno. There is a case to be made that this Abandonment therefore does "materially injure the public". Every sweltering summer day of every future year this blacktop will add to the ever-rising temperature in Downtown Reno.

In 2021, the City Council approved only its second Development Agreement with a private party when it accepted presentations from the Applicant regarding the improvements it planned for Downtown Reno.

Section 2.02 a. of the Development Agreement includes the following statement:

*"The District will include....an array of other commercial, retail, plaza, **green space**...." (District presumably refers to what the Applicant named the Neon Line District.)*

It's quite possible that the Applicant's "Master Plan" includes green space but, so far, I see no additional green space, just a lot of blacktops and empty lots.

During an interview with KTVN Reno's Arianna Bennett on March 4, 2022, Mr. Jeff Jacobs announced that he had a **Master Plan** in place for the development of the many Downtown parcels he had already purchased, as well as those he planned to purchase. And yet, as of my writing of these public comments, the City Council has apparently not yet been afforded the opportunity to see that Master Plan. Even a comment/request from CM Taylor at the December, 2023 Annual Review of the Development Agreement that the public are very interested in seeing the Master Plan, and that evoked a response from the Applicant's representative that said plan would be coming "soon", has not changed anything.

This current Abandonment request is yet another "drip" from the Applicant's Master Plan. How many more "drips" are forthcoming? How many might cause concerns for residents? How can City Staff and the City Council effectively evaluate the likely effects of any individual development request from the Applicant without knowing the breadth and land use nature of the Applicant's full Master Plan?

As part of your analysis and decision on this current Abandonment request, **I respectfully ask that the City Council Members insist the Applicant makes the Master Plan available to them now and that they, in turn, make the Master Plan immediately available to the public.**

I am opposed to Jacobs request for abandonment of part of Bell Street and the intersecting alleys. I drove this area and got to see Reno's historic African American Church (The Bethel AME church) nestled in this corner, surrounded by those encroaching office buildings, which I believe are already empty.

The church is already being smothered and swallowed up by these nondescript buildings. To have the city part with this little available access would be a huge mistake, and practically make access to this location, almost impossible. And, who knows what Jacob's true agenda truly is? Most likely they will tear down both of those office buildings....and for what purpose...more tear downs with no replacements? There is already the large parking area on the other side of the alley which borders the Glow Plaza.

We have already learned about what can occur with street abandonment in Reno, with no parameters established or time line for changes and we just totally forgo any control or jurisdiction of public access right away of that space forever. Big mistake!

Moreover, since this church was brought to our attention, I think the city needs to take a different approach and feature the importance of this institution. It is on the US National Register of Historical Places and should be treated with such dignity it deserves and assist the church to consider creating a museum. And, continue to have public access on Bell and on the alleys surrounding it.

Educate Jacobs on what a treasure this church is and vote **NO** on the abandonment of part of Bell Street and intersecting alleys.

The implosion of the Mapes was done to shade prior actions of influencers and councilpersons. Will this be the same?

Reno has over 70 national historic register properties, many of which are near the Jacobs current property. Is the Lear/First Church of Christ Science, the the Arch or Twaddle House safe?

Why have so many labored to protect and tell the stories of these properties?
