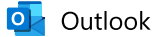

To Whom It May Concern:

I am writing to you to request that Sunny Hills collaborate with organizations to offer an alternative water source on their property. Providing water for the Virginia Range Wild Horses is **not** against the law. Ensuring water access for the Virginia Range wild horses is perfectly **legal**.

I am urging the City to plan for future developments with a **clear** strategy for water access for the horses. It is essential to avoid situations that lead to horses being removed, or facing a lack of cooperation in establishing alternative water sources. Many residents, and wild horse advocates nationwide would love to see Sunny Hills improve its relationship with the community by respecting the area's history as well as the concerns of local residents.

The owner and company representatives often lack communication and presence in the community, ignoring the needs of most community members, which include:

- *The desire for safe roads
- * The protection of the Virginia Range Horses
- * Opposition to the rounding up and permanent removal of VR horses (which raises concerns about them being sold for slaughter), and
- * The prevention of horses and wildlife suffering from thirst.

In a time when our country needs it most, collaboration between developers and local residents/wild horse advocates is essential.

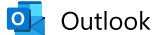

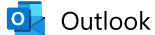
