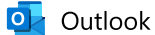

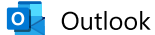

Dear Washoe County Code Officials,

As a resident of Stead, I am writing to express my deep concerns regarding the proposed Lyten lithium-sulfur battery gigafactory in our neighborhood. While I understand the potential economic benefits this project may bring, I believe the risks and negative impacts on our community far outweigh any advantages.

First and foremost, I am troubled by the apparent disregard for the safety and well-being of Stead residents. It seems that external self-interests are driving investment in our neighborhood, and we are suffering as a result. The decision to cancel the Reno Air Show due to safety concerns related to development, only to replace it with a potentially more dangerous year-round industrial facility in our backyards, is both ironic and alarming.

Our infrastructure is already severely lacking, and this massive project threatens to overwhelm our community further. The roads in Stead are inadequate for current traffic levels, let alone the increased industrial activity this plant would bring. Our water supply is already strained, and the quality is poor. How will this facility impact our already limited resources?

Safety concerns are paramount:

1. Fire and Explosion Risks: Lithium battery production carries significant risks of fires and explosions. Our local emergency services are not equipped to handle such industrial accidents.

2. Chemical Exposure: The use of hazardous materials in battery production puts our community at risk of chemical exposure, especially in the event of an accident.

3. Environmental Impact: The 125-acre campus will undoubtedly affect our local ecosystem. What studies have been done to assess the long-term environmental consequences?

4. Air and Water Quality: How will the facility ensure that our air and water are not further contaminated?

The proposed plant also raises serious quality of life issues:

1. Noise Pollution: Industrial activity of this scale will likely increase noise levels in our residential areas.

2. Property Values: The presence of a large industrial facility could negatively impact our property values.

3. Community Character: This development threatens to fundamentally alter the character of our neighborhood.

Furthermore, I am concerned about the lack of transparency and community involvement in this process. It appears that decisions are being made without adequate input from those of us who will be most affected.

I urge you to reconsider this project and prioritize the needs and safety of Stead residents over external economic interests. At the very least, we demand:

1. A comprehensive environmental and safety impact study
2. Full transparency on all aspects of the project
3. A clear plan for infrastructure improvements to support this development
4. Guarantees for the safety and well-being of residents
5. A community-driven decision-making process

Our neighborhood should not be sacrificed for the sake of industrial development. We deserve to have our voices heard and our concerns addressed.

I look forward to your response and to seeing concrete actions taken to protect our community.

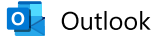
