RESOLUTION TO VACATE EXISTING IRREVOCABLE OFFER OF DEDICATION
ALONG GOLDEN VALLEY ROAD
AND
ESTABLISH REVISED IRREVOCABLE OFFER OF DEDICATION
ALONG GOLDEN VALLEY ROAD

WHEREAS, it is necessary for the City to provide public streets; and

WHEREAS, an irrevocable offer of dedication for additional right of way for the widening of Golden Valley Road was offered for dedication by Document No. 5162540, recorded April 6, 2021, and is described in Exhibit A, attached hereto; and

WHEREAS, said offer of dedication has not been accepted by the City; and

WHEREAS, the City Council finds that a revised irrevocable offer to dedicate additional right of way for Golden Valley Road replaces the subject irrevocable offer to dedicate recorded as Document No. 5162540; and

WHEREAS, the proposed revised irrevocable offer of dedication is described in Exhibit B, attached hereto.

NOW THEREFORE, BE IT RESOLVED by the City of Reno City Council, pursuant to the authority granted by NRS 278.480 hereby vacates the irrevocable offer to dedicate additional right of way for the widening of Golden Valley Road by Document No. 5162540 as described in Exhibit A.

BE IT FURTHER RESOLVED by the Reno City Council that the subject irrevocable to dedicate is being superceded by relocation and is no longer needed.

BE IT FURTHER RESOLVED by the Reno City Council that the revised irrevocable offer to dedicate is described in Exhibit B.

BE IT FURTHER RESOLVED by the City of Reno City Council that the public will not be materially injured by the proposed vacation.

BE IT FURTHER RESOLVED, and hereby ordered that this Resolution be recorded in the office of the Washoe County Recorder.
