**Subject:** Staff Report (For Possible Action): Acceptance of donation and Memorandum of Understanding with Sierra Nevada Community Aquatics, Inc. (SNCA) to purchase a scoreboard and timing clocks for Pennington Moana Springs Community Aquatics and Fitness Center in the amount of \$125,000.

### Summary:

The proposed Memorandum of Understanding (MOU) between Sierra Nevada Community Aquatics, Inc. (SNCA) and the City of Reno Parks and Recreation Department details that SNCA will contribute \$98,328.70 for the second scoreboard and an additional \$25,449 for four wall-mounted digital pace clocks. The City of Reno will cover the infrastructure costs required for these enhancements, estimated at \$35,357.87. The agreement specifies that the equipment will be installed in fully operational condition, with any cost overages being the responsibility of the City. Additionally, SNCA is granted the right to place a donor name on the scoreboard, highlighting the collaborative nature of the project.

**Background:**

The proposed MOU between SNCA and the City of Reno Parks and Recreation Department is intended to enhance the Moana Springs Community Aquatics and Fitness Center. This agreement represents a collaborative effort to improve the facility by installing additional equipment, specifically a second scoreboard and digital pace clocks. The MOU outlines the financial contributions and responsibilities of both parties, ensuring that the necessary infrastructure and equipment are provided to elevate the user experience at the center.

**Discussion:**

The partnership between the City of Reno and SNCA aims to significantly enhance the amenities at the Moana Springs Community Aquatics and Fitness Center. The installation of advanced equipment, such as the second scoreboard and digital pace clocks, is expected to improve the facility's functionality and user experience. The MOU's provisions ensure clear financial responsibilities and infrastructure commitments, promoting accountability and efficient project execution. This collaboration exemplifies the positive impact of public-private partnerships in advancing community recreational facilities, and ongoing communication between the City and SNCA will be crucial for the project's success.

**Financial Implications:**

The total cost of infrastructure work to be paid by the City to enable the installation of the secondary scoreboard is anticipated to be \$35,357.87. The contribution from SNCA will offset City cost for equipment and installation.
