It has come to my attention that Oscar Delgado has submitted his resignation as the Ward 3 Council member. This is an unfortunate circumstance that caught many by surprise. I always appreciated Oscar for his service to the City and his willingness to work with me in the Northern Nevada Building & Construction Trades Council (NNBCTC) and the greater building community.

During the 2012 City Council election cycle, as a representative of the NNBCTC, we interviewed a number of qualified candidates, including Oscar and a number of others. During that time period, I was introduced to Michael “Mike” Trudell, who was running as a candidate for the Ward 3 seat. Mike’s broad experience as the general manager of the Caughlin Ranch Master Planned Community, and years of experience as an urban planner, including the City of Reno, was of interest to me and other representatives who were interviewing candidates. Mike’s background included a number of

years working construction through our NNBCTC affiliate, Local 169, provided him an understanding of various construction trades and the building industry. It is my understanding that he earned a bachelor's degree in Political Science and Public Policy from Willamette University by working his summers as a laborer on a variety of projects in Reno, Sparks and Washoe County. Although Mike was not successful in his bid for the Ward 3 seat, I continued to work with him on other matters and continued to value him as a potential candidate for future openings, including the At Large vacancy in 2019. From my experience of working with Mike, I would strongly endorse him for the appointment to the Ward 3 vacancy. I know the application Mike filed for this seat states that he would not run again in 2024. This gives the Reno City Council a great compromise option. It would save the taxpayers \$175K-\$350K for a special election, allow it to continue the work it needs to do and puts the final decision back in the hands of the voters in a relatively timely manner.
