
I am excited to submit this letter in support of Courtney McKimmey's appointment to serve as the Reno City Councilperson for Ward 3.

**Madame Mayor and Honorable City Council Members:**

**I'm commenting today on behalf of a sub-set of a Group of Ward 5 residents that interviewed by Zoom the three finalists you selected to fill out the Ward 3 open seat through 2024.**

- **Sunny Allen**

- Carly Borchard
- Pam McNeil
- Gary Cecil

Council seemed to find our input useful, so we decided to repeat our interview process for the Ward 3 replacement. We found our interviewing experience to be extremely useful as a supplement to your own individual questions for those finalists. Rather than ask the same questions of all finalists, we were able to customize ours to the individual application materials and prior statements made. As a small group, we were also able to follow further down the trail of the answers given and engage in a productive give-and-take.

It's clear that the City faces many pressing issues that go beyond the artificial boundaries of wards, so our Group was delighted when Kyle, Sean, Miguel, and Courtney all agreed to spend an hour with us, individually, on Zoom.

As we did last time, we based our evaluation of the finalists on a set of qualities we feel are essential for a Council Member, some of which include: integrity, demonstrated competence, relevant knowledge and experience, independence, open-mindedness, and objectivity.

However, we also bore in mind Council's strong belief that it was necessary to appoint a replacement now, rather than wait to seat an elected person in March next year. Mr. Thornley pointed out that the annual budget cycle begins soon and there are also many other important issues to manage, and that Ward 3 and City residents as a whole needed a representative quickly. Considering this, we gave precedence to the selection criteria of knowledge and experience as indicators of who could best "hit-the-ground-running".



After consultation and discussion, we respectfully offer our recommendation that you select Kyle Edgerton to fill the current Ward 3 term through 2024. Following are some brief, supporting comments:

- We felt that his experience working with marginalized communities demonstrated the skills needed to work collaboratively, without rancor, and with a consensus-building mentality.
- Coupled with this experience, being bi-lingual in Spanish and English augers well for his ability to communicate effectively with all the Ward 3 residents.
- Speaking of communication, Kyle's answers were concise, right on point, and easy to understand.
- While all the finalists spoke well about their aspirations to work collaboratively, we felt that Kyle's answers were the most realistic about what *could* be achieved, rather than what *should* be achieved.
- Kyle's plan to scale back his practice's client load seemed a practical way to ensure he can meet the time demands of being a Council Member.
- Unlike the Ward 5 finalists, where one had very recent and relevant experience in evaluating development projects, none of the Ward 3 finalists had comparable experience. However, during his UC Davis legal studies, Kyle took courses in land use and planning. Moreover, during questioning, he initiated discussion about the Reno City Master Plan and Administrative Code and understood the important bases they provide for deciding on development projects.

- During discussion about the Ballpark in Ward 3, Kyle had a clear understanding of the value of that entity to the community yet understood why that 30-year financing deal with the City needed to continue to be reviewed annually. This was one example demonstrating that he has been following City business for a number of years and can apply lessons learned from past experience.

We must also say that Sean, Miguel, and Courtney displayed great integrity, caring, and professionalism during our interviews. They also showed very effectively that their concern is for the best interests of the City of Reno in general and the residents of Ward 3 in particular. We respect so much that they are willing to put themselves into the public spotlight and allowed us to get to know them better.

Whomever Council selects on October 26, our Group is committed to helping that person be successful. While we are not Ward 3 residents, we *are* residents of the City as a whole and will continue to be interested in contributing positively to our community.
