

**RESOLUTION ESTABLISHING UPDATED RENO CITY COUNCIL MEETING DATE AND TIME FOR THE NOVEMBER 16, 2022 AT 10 A.M. MEETING TO NOVEMBER 18, 2022 AT 3 P.M.; TOGETHER WITH OTHER MATTERS PROPERLY RELATING THERETO.**

**WHEREAS**, Section 2.040 of the City of Reno Charter requires that the Reno City Council establish by Resolution the dates and times for its two (2) regular meetings to be held each month.

**WHEREAS**, during the 2022 calendar year and the month of January 2023, unless a different date is specifically designated by this Resolution, the Reno City Council shall meet regularly on the second and fourth Wednesdays of each month.

**WHEREAS**, at the October 13, 2021 City Council meeting Council passed Resolution No. 8967 setting the meetings dates for the 2022 calendar year and January 2023; exceptions to this previously approved schedule are:

(1) The November 16, 2022, 10 a.m. meeting has been changed to November 18, 2022 at 3 p.m.; and

**WHEREAS**, the start time for all City Council meetings, which dates are set by this Resolution, shall be noticed for 10:00 a.m. unless in the discretion of the Mayor, City Council or City Manager that earlier start time is needed to conduct the business for the City.

**WHEREAS**, the remaining meetings of 2022 and January 2023 will stay the same: December 7, December 14, January 11 and January 25.

**WHEREAS**, in accordance with applicable laws, the Reno City Council may meet on such additional meeting days as are necessary to conduct the business of the City.

**NOW, THEREFORE, BE IT RESOLVED THAT:** During the 2022 calendar year and the month of January 2023, unless a different date is specifically designated by this Resolution, the Reno City Council shall meet regularly on the second and fourth Wednesdays of each month.

**BE IT FURTHER RESOLVED THAT:** The start time for all City Council meetings, which dates are set by this Resolution shall be noticed for 10 a.m. unless in the discretion of the Mayor, City Council or City Manager that earlier start time is needed to conduct the business for the City.

**BE IT FURTHER RESOLVED THAT:** The Reno City Council may meet on additional days as noticed pursuant to law; and as necessary to conduct the business of the City.
