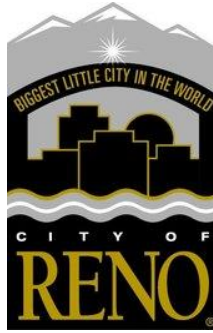

Re: Suspension - City of Reno Business License R101276Q (Package Alcoholic Beverage License)

Dear Licensee:

This correspondence serves as formal notification that the above referenced City of Reno ("City") business license is hereby suspended. Based upon the enclosed order issued by the Administrative Hearing Officer dated November 15, 2022, your license to conduct the sale of alcohol at this business is suspended from November 28, 2022 to December 14, 2022 at which time you will be required to go before Reno City Council as a requirement of the suspension.

This suspension does not impact your ability to continue operating your non-alcohol related business; however, alcohol sales are strictly prohibited. Furthermore, during the suspension, there is to be no alcohol visible on the shelves of the store and any refrigerators with alcohol must be locked. Again, alcohol must not be sold or provided free of charge whatsoever.

Be advised that you have the right to appeal this decision. Pursuant to RMC Sec. 4.04.160:

"Revocation or Suspension: The decision of the administrative hearing officer following a show cause hearing for revocation or suspension under section 4.04.190 may be appealed by the city or any aggrieved party to municipal court, or to another tribunal if required by law, within 30 days after notice of the final decision. If the license is revoked or suspended, no business shall be conducted under that license until such time as an appeal has been heard and the revocation or suspension has been reversed."

Now therefore it is ordered as follows: I find there is sufficient evidence presented at the hearing conducted on November 15, 2022 to warrant a suspension of the liquor license R101276Q for Wrightway Market. The suspension is to begin on November 28, 2022 and last up and until December 14, 2022. On December 14th, 2022, the license holder is to appear before the Reno City Council to determine if the liquor license should be renewed or not. If City Council renews the license this suspension is lifted. The suspension only impacts the sale of alcohol and does not prevent the store from operating in the sale of other goods. During the suspension there is to be no alcohol visible on the shelves of the store. Any refrigerators with alcohol must be locked.
