Mikki Huntsman, City Clerk, gave a presentation on this item. Mikki informed the City Council on the process of today's agenda item by asking them to decide how many applicants the Council would like to narrow the list of candidates down to. The next part of the process includes each member of the Council to rank their finalists on a scorecard. Then there would be a short recess to tally the scorecards. After the scorecards have been tallied, the Council will take a vote to confirm the finalists.

Mayor Schieve recommended choosing five finalists and interviewing the top three. The mayor also thanked everyone who applied for the position and asked all of the candidates to stay engaged and involved in local government.

Councilmember Duerr agreed that it would be best to narrow the candidates to the top five finalists. Councilmember Duerr said that the number of points each candidates get is not dependent on the position the Council puts them in. They are all awarded one point for being in the top five of any of the Council Members lists.

Councilmember Delgado and Councilmember Weber agreed that narrowing the list to the top five and then tallying the top three from all member's selection cards would be the best process.

Vice-Mayor Reese also thanked everyone who applied for the position and agreed to the top five selection process.

Councilmember Duerr also thanked everyone who applied for the position and asked them all to stay engaged.

Vice-Mayor Reese explained the process of narrowing down the list and looking for a colleague with a resume that demonstrates community involvement and effective communication skills.

Councilmember Duerr mentioned having a similar process of first looking at the candidate's background, community service, balance amongst the other Council members, and a colleague that has effective communication skills.

Councilmember Weber mentioned being prepared for the meeting with some names as well, but the list continued to grow from hearing public comment and the support from the community for certain candidates. Councilmember Weber said that it would be important for someone to speak on the process of choosing the candidate after today and the public outreach and involvement with that process.

Mikki said that the during the following week of this meeting, there would be two meet-and-greet sessions for the candidates and the public, one on Tuesday August 30th and one on Wednesday August 31st from five to seven. There has been a call sent to Ward 5 residents to ask them what questions they have for the candidates. The meet-and-greets would be a question-and-answer session and then there would be time for the candidates to walk around and meet individually with Ward 5 residents.

Mayor Schieve reminded everyone that there are many commissions and boards through the City of Reno that people could serve on to be part of the process.

The Clerk's office tallied the votes with 25 in total. Five votes each from each present council member. They tallied four votes each for Kathleen Tylor, Elliot Malin, and Alexander Goff. Jacob Williams got three votes. Zelalem Bogale,

Sonya Giroux, and Albert Rogers got two votes each. Thomas P. Peterson, Stan Marks, Jacqueline Duran, and Earstin E. Whitten received one vote each.

Vice-Mayor Reese thinks the top three candidates should move forward as finalists.
