ORDINANCE NO.

AN ORDINANCE TO AMEND TITLE 18, CHAPTER 18.02 OF THE **RENO** MUNICIPAL CODE, **ENTITLED** "ZONING," REZONING A ±112.6 ACRE SITE LOCATED WITH ±1,981.32' OF FRONTAGE ON LEMMON DRIVE, ±476.82' OF FRONTAGE ON SKY VISTA PARKWAY, AND ±732.1' OF FRONTAGE ON VISTA KNOLL PARKWAY FROM ±112.6 ACRES OF PLANNED UNIT DEVELOPMENT (PUD) TO ± 48.31 ACRES OF **MULTI-FAMILY** RESIDENTIAL (MF-14), ±44.39 ACRES OF PARKS, GREENWAYS AND OPEN SPACE (PGOS), ±16.17 ACRES OF MULTI-FAMILY RESIDENTIAL (MF-30), AND ±3.73 ACRES OF GENERAL COMMERCIAL (GC); TOGETHER WITH MATTERS WHICH PERTAIN TO OR ARE NECESSARILY CONNECTED THEREWITH.

THE CITY COUNCIL OF THE CITY OF RENO DO ORDAIN:

SECTION 1. Chapter 18.02 of the Reno Municipal Code is hereby amended by adding thereto a new section to be known as Section 18.02.102(b).1431 relating to a \pm 112.6 acre site located with \pm 1,981.32' of frontage on Lemmon Drive, \pm 476.82' of frontage on Sky Vista Parkway, and \pm 732.1' of frontage on Vista Knoll Parkway and more particularly described in the attached "Exhibit A-1," "Exhibit A-2," "Exhibit A-3," "Exhibit A-4," and "Exhibit A-5," and rezoning said property from \pm 112.6 acres of Planned Unit Development (PUD) to \pm 48.31 acres of Multi-Family Residential (MF-14), \pm 44.39 acres of Parks, Greenways and Open Space (PGOS), \pm 16.17 acres of Multi-Family Residential (MF-30), and \pm 3.73 acres of General Commercial (GC), the same to read as follows:

Sec. 18.02.102(b).1431. The zoning of the City of Reno as heretofore established is hereby amended in the manner shown on the map labeled Case No. LDC23-00005, thereby changing the use of land indicated therein, relating to a ± 112.6 acre site located with $\pm 1,981.32$ ' of frontage on Lemmon Drive, ± 476.82 ' of frontage on Sky Vista Parkway, and ± 732.1 ' of frontage on Vista Knoll Parkway more particularly described in attached "Exhibit A-1," "Exhibit A-2," "Exhibit A-3," "Exhibit A-4," and "Exhibit A-5," and rezoning said property from ± 112.6 acres of Planned Unit Development (PUD) to ± 48.31 acres of Multi-Family Residential (MF-14), ± 44.39 acres of Parks, Greenways and Open Space (PGOS), ± 16.17 acres of Multi-Family Residential (MF-30), and ± 3.73 acres of General Commercial (GC).
