AN ORDINANCE TO AMEND TITLE 18, CHAPTER 18.02 OF THE RENO MUNICIPAL CODE, **ENTITLED** "ZONING", REZONING A ±0.16 ACRE SITE LOCATED **DIRECTLY NORTH OF CRAMPTON STREET ±170 FEET** EAST OF ITS INTERSECTION WITH WELLS AVENUE FROM MULTI-FAMILY RESIDENTIAL – 14 UNITS PER ACRE/ WELLS AVENUE NEIGHBORHOOD PLAN (MF-14/WANP) TO GENERAL COMMERCIAL/ WELLS **AVENUE NEIGHBORHOOD PLAN** (GC/WANP); **TOGETHER WITH MATTERS WHICH PERTAIN TO OR** ARE NECESSARILY CONNECTED THEREWITH.

THE CITY COUNCIL OF THE CITY OF RENO DO ORDAIN:

SECTION 1. Chapter 18.02 of the Reno Municipal Code is hereby amended by adding thereto a new section to be known as Section 18.02.102(b).1434 relating to a ± 0.16 acre site located directly north of Crampton Street ± 170 feet east of its intersection with Wells Avenue and more particularly described in the attached "Exhibit A" and rezoning said property from Multi-Family Residential – 14 units per acre/ Wells Avenue Neighborhood Plan (MF-14/WANP) to General Commercial/ Wells Avenue Neighborhood Plan (GC/WANP), the same to read as follows:

Sec. 18.02.102(b).1434. The zoning of the City of Reno as heretofore established is hereby amended in the manner shown on the map labeled Case No. LDC23-00023, thereby changing the use of land indicated therein, relating to a ± 0.16 acre site located directly north of the intersection of Crampton Street ± 170 feet east of its intersection with Wells Avenue and more particularly described in the attached "Exhibit A", and rezoning said property Multi-Family Residential – 14 units per acre/ Wells Avenue Neighborhood Plan (MF-14/WANP) to General Commercial/Wells Avenue Neighborhood Plan (GC/WANP).

SECTION 2. This Ordinance shall be in effect from and after its passage, adoption and publication in one issue of a newspaper printed and published in the City of Reno and upon approval of conformance review for the associated Master Plan amendment (LDC23-00023 - 455 Crampton Street Master Plan and Zoning Map Amendments) by the Truckee Meadows Regional Planning Agency.
