To Council Members and City Manager: I participate in Reno programs during Senior Games and enjoy them. I speak with many other seniors who do activities at Paradise Park, Neil Road and Evelyn Mount centers.

Many use the bus or Access to get there. I think \$200,000 is a minimum amount for improved transportation for seniors. I think that you need to fund rides on all the current providers used by seniors---RTC, N4, Sanford Center, Access to Healthcare, Lyft and Uber. This voucher system that you describe is a lot more complicated for seniors than you realize. You will need someone to help schedule coordinate many rides for seniors who don't use technology, train seniors who don't regularly use transportation services. You need to budget for staff to do this.
