RESOLUTION DONATING COUNCIL DISCRETIONARY FUNDS TO THE TRUCKEE MEADOWS COMMUNITY COLLEGE FOUNDATION TO SUPPORT THE EQUITY, INCLUSION AND SUSTAINABILITYN OFFICE'S MISSION TO BUILD AND MAINTAIN A NON-DISCRIMINATORY ENVIRONMENT IN ALL FACETS OF TMCC FROM COUNCILMEMBER TAYLOR (\$2,000) AND COUNCILMEMBER EBERT (\$1,000) IN THE TOTAL AMOUNT OF \$3,000. (GENERAL FUND)

WHEREAS, the Equity, Inclusion, and Sustainability Office contributes to developing a diverse workforce, through outreach and affirmative action efforts, that reflects a demographic distribution in the service area; and,

WHEREAS, the Equity, Inclusion, and Sustainability Office contribute to providing leadership and direction in advocating, facilitating, supporting, and coordinating the development and delivery of programs; and,

NOW, THEREFORE BE IT RESOLVED that the City of Reno approves the Council donation from Councilmember Taylor (\$2,000), and Councilmember Ebert (\$1,000) for a total sum of Three Thousand Dollars (\$3,000) to the Truckee Meadows Community College Foundation to support the Equity, Inclusion and Sustainability Office's mission to build and maintain a non-discriminatory environment in all facets of Truckee Meadows Community College; and,

BE IT FURTHER RESOLVED, that should the above donation or any portion thereof not be used for the purpose as set forth in this Resolution, any unused funds shall be returned to the City of Reno.
