Dear Mayor Schieve, members of the Reno City Council, City Manager Thornley, Mr. McArdle, Mr. Edelstein, Ms. Berner, Ms. Hafey, and Ms. Brown,

I hope this finds you well. I'm writing with respect to the proposed \$1 million that Council will be discussing allocating toward landscaping and fencing improvements at the Lear Theater at its March 8 meeting. I'm concerned that the City might be getting ahead of itself if contemplating any major changes in fencing around the building, and I hope this item is intended only to fund more secure temporary fencing in order to ensure the building's safety while it remains unoccupied. I would also like to suggest that the City immediately commission a Historic Structures Report for the building, as I'll explain below.

Any permanent fencing, or even the idea of installing a permanent fence, would need first to be approved by the City's Historical Resources Commission. Constructing a permanent fence around a historic property constitutes a significant alteration of its setting and is often not advised.

In the case of the Lear Theater (the First Church of Christ, Scientist), the architect Paul Revere Williams carefully designed the setting and landscaping of each of his buildings in close conjunction with its architecture. A fence would deviate substantially from the original design and would warrant substantial consideration. It is also unadvisable considering that the future use of the building remains unknown. So again, if the City's intent is to install more secure temporary fencing that can both protect the building today and easily be removed later, then that seems a proper use of public funds, but only if it is temporary.

I also want to take this opportunity to express my grave concerns upon hearing from multiple sources that City staff are already discussing potentially leasing or engaging in a developmental relationship with private entities regarding the building. With respect, I hope those conversations can stop immediately so that the City can take a more methodical, informed, and transparent approach to its stewardship of this architectural treasure.

The first step any public entity should take when acquiring a historic building of this level of local, state, and national significance, is to commission a Historic Structures Report. This is more than a simple inspection or conditions assessment. It is a specific type of report that is undertaken in order to assess the current condition of a historic property with an eye to its responsible historic preservation--regardless of its future use. The City previously commissioned such a report for the Southern Pacific Railroad Depot from Architectural Resources Group; it's even featured on their website. <https://www.argcreate.com/portfolio/historic-structure-reports-rehabilitation/>. I have a copy of it if you need one.

An excellent explanation of Historic Structures Reports with several examples is found on the website of the Washington State Department of Archaeology and Historic Preservation:

From that site: "A historic structure report (HSR) provides documentary, graphic, and physical information about a property's history and existing condition. Broadly recognized as an effective part of preservation planning, a HSR also addresses management or owner goals for the use or re-use of the property. It provides a thoughtfully considered argument

for selecting the most appropriate approach to treatment, prior to the commencement of work, and outlines a scope of recommended work."

It is critical for the City to acquire the information provided by such a report before making any more decisions regarding the building, its setting, or its future ownership, use, or rehabilitation. It will ensure that the building has been properly documented and assessed by those with professional expertise in historic buildings. As with the Depot, this report can also identify several opportunities for adaptive reuse, presenting different options for potential reconfiguration to enable various options without sacrificing historical integrity.

With that report in hand, the City can then schedule a public meeting or series of meetings with the community, as we have all expected to happen, where the results of that report can be made public and openly discussed, and the community as a whole can help determine the best path forward, given the demonstrated conditions, challenges, and opportunities identified in it.

Dear Mayor Schieve and City Council:

Agenda item D.5 regarding allocating to specific projects remaining American Rescue Plan Act funds received by the City -- this item includes under "Parks and Recreation" a line item proposing \$1,000,000 allocated to the "Lear Theater" for "Landscaping/Fence Upgrades". I am in favor of this, but have concerns:

Firstly, thank you for including this allocation to the very important historic building, of which Reno is now assuming ownership. As you know, this building is a prominent and much loved Reno historic resource. It is included on not only the City of Reno's Register of Historic Places, but also on the Nevada State Register of Historic Places and the National Register of Historic Places.

With respect to this funding line item, I encourage you to allocate these funds not just to "landscaping", but to this building and historic property overall, taking into account the necessary "first steps" to secure and protect this important city community asset.

Yes, landscaping and a better looking fence (than the current chain-link) are needed. But as a well-known historic resource asset, any fencing or landscape improvements need to be correct in the context of this structure.

The fencing should be temporary and easily removable, until an historically appropriate landscape design is approved.

Also needed is an overall assessment of the property. This includes commissioning a "Historic Structure Report"

prepared by a qualified consultant. (As was prepared by the City for the SPRR Depot.)

Other important steps in moving ahead with this building include meetings with the public and (of course) meeting with and seeking input from the City of Reno's

Historical Resources

Commission.

For this item-D.5 on your March 7, 2023 agenda -- please do approve funding, but for fencing only if the intent is for the fencing to be temporary (and albeit, more attractive than chain link). Please also consider directing City staff to allocate some of these available funds to commission a Historic Structure Report for the building as soon as possible.

RE: \$2.1 million for Reno Tennis Center. I support funding repairs and maintenance to the courts themselves. In regard to the canopies proposed, more courts are needed in the community rather than those types of upgrades. It is great so many people are wanting to play pickleball and tennis in our community; pickleball courts are at a premium. We don't have enough, and it is a sport that is keeping a lot of us moving - great for public health. Also, the Reno Tennis Center needs to be run like a public facility, not a country club, and this funding should only be awarded contingent upon an agreement that assures this. Current management sells "memberships," and members get privileges that the general public do not get. Those who can afford the memberships and to play every day and put the most wear and tear on the courts are in effect paying less per session than those who do not sign up for membership and do not

have as much free time to be on the courts every day. We need policies that support public health goals of getting those who are not playing/moving to get moving more, not policies that favor those who are already playing/moving daily or almost daily. In my observations, current members could certainly afford to pay the \$4/session fee that the general public pays, and this would bring in more revenue to support the facility. Punch cards for 10 sessions or whatever could reduce administrative costs of having everyone pay each time they come. In closing, I support repair/upkeep of the Reno Tennis Center's tennis and pickleball courts if these courts will be run like a public facility, not a country club. I also support spending any other funds on funding more courts in our community.

Greetings,

My name is Richard Jay and I have been a resident of Reno here since 1967. I've seen this community grow from a small city to what it is today and I know what it will be like in 10 years from now. It's a great community live, and we have much to offer. One thing that we are severely lacking is flat fields for youth, sports, soccer, lacrosse, and other field sports. Last estimate from the parks and recreation department showed that we are lacking 46 fields now and that number continues grow as our community grows. Now more than ever we need to start planning and building new fields.

The Covid funding could make a major impact building those badly needed 46 fields. The plan is pretty straightforward, a joint cooperation between the City of Reno and Great Basin Youth Soccer along with the Reno Youth Sports Association, we can build up to 10 fields out there, more for the smaller kids. That along with eventually finishing Mill Street, we can have upwards of 30n new fields that are badly needed.

I have been working closely with the former Parks and Recreation Director and staff to come up with a plan that makes sense. We spent countless hours in zoom meetings, working with planning engineers and surveyors to come up with a plan. CFA, Inc. has graciously donated their time and services to develop the tentative master plan. GBYSL has been working with the city managers office to come up

with a MOU that makes sense. The plan is the users will be responsible for all maintenance, mowing, water, utilities, sod management and repairs. This will not be funded by city tax dollars, the end users will be responsible. Much like Moana is now, no tax dollar are used there for maintenance.

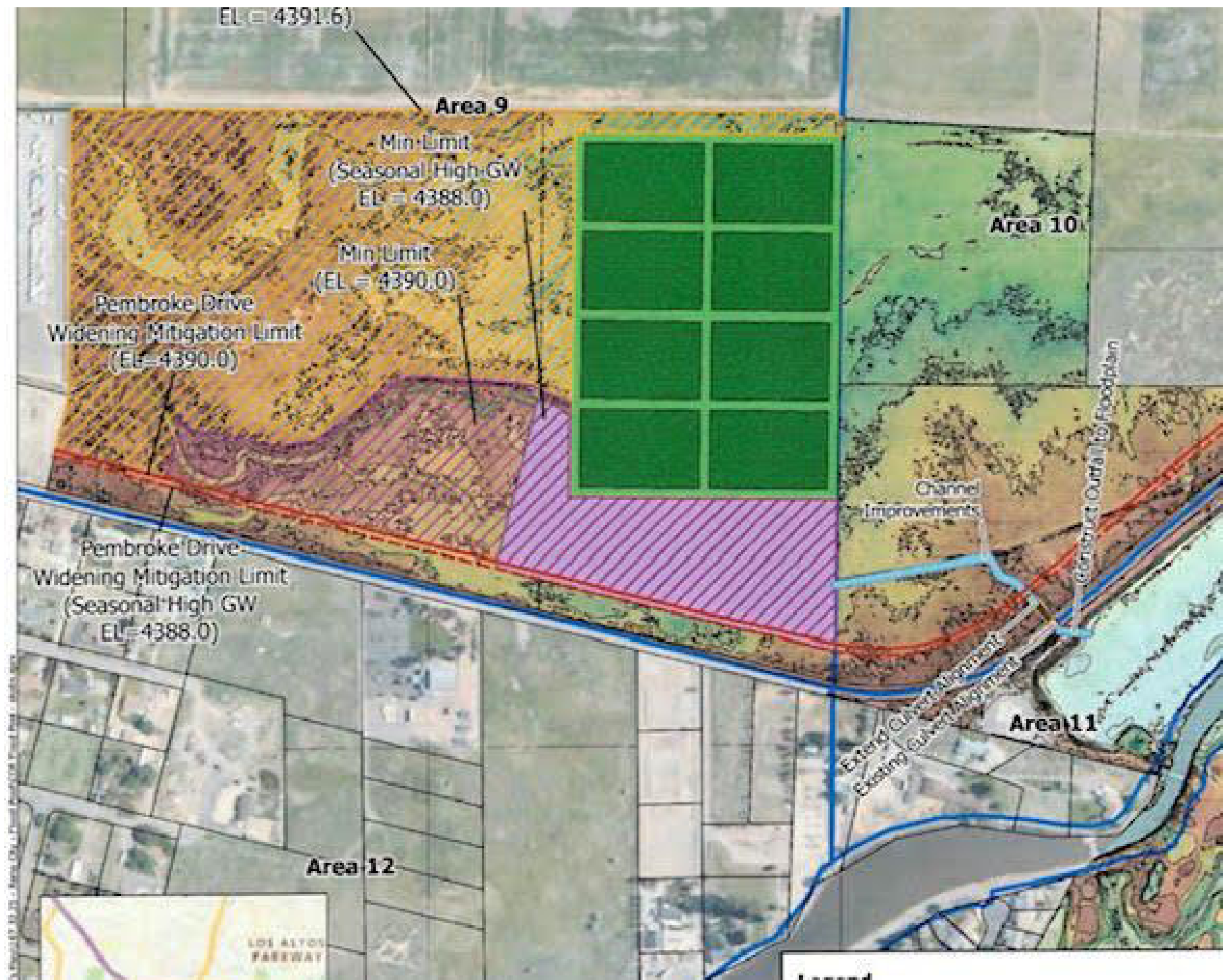
Bottom line it's a win-win for all, a win for the city, a win for a community, and a win for our youth sports players in our community. Not to mention the economic impact that our community can receive when we start hosting large youth flat field tournaments at Pembroke, as well as Mill Street.

Reno currently has no venue with more than three large fields, Reno is not built any major complex since Moana Springs Sports Complex, which was actually funded privately and to this day is maintained privately. While Cyan Park was built it lacks parking and overall space games. It is a great facility for practices only.

There will be no permanent structures out there, concessions will be handled by food trucks, portable bathrooms, and there will be a section out there for local bike riders, riding in the area to pull into to rest, get food and make repairs to their bikes if needed.

I urge you to continue to support this badly needed flat field facility.

Greetings Mayor Schieve, City Council Members, and City Management,

I am writing from the Wild Horse Advocacy perspective on Item D.5 for tomorrow's Council consideration. As noted in the supporting documents, \$500,000 is listed for Virginia Range Horse fencing. I wanted to offer the priorities from the boots on the ground perspective of the issues we face.

An immediate need is fencing of a wildlife preserve to allow access to a natural water source for not only the VR horses, but also other wildlife. This project consideration is at the intersection of Alexander Lake Road and Steamboat Creek. Natural water sources mean, no pipes, no water fills, to replacement parts. Just wildlife fencing of the direct area that would tie into existing fencing. This has been looked at by several city staff, as well as advocates. As a partner project, our organizations would search for and try to secure grants for education kiosks, as well.

Second, but equal priority, is the fencing of the Geiger Grade funnel. This is a multi agency project, and while most falls on land outside of the City limits, it **directly** affects public safety on City of Reno streets and neighborhoods. With over 15,000 homes added to southeast Reno in the last decade in what used to be open rangeland or ranch land, planted grass and landscaping while not having fencing installed first has created a risk to public safety as VR horses and other wildlife access the roadways. Once this area is sealed with fencing/cattle guards, the issues in this regard will drop dramatically.

A wildlife corridor that allows the movement for human recreation, wildlife, and VR horses is another a top priority for community, public safety, and

environment/ecosystem. We encourage a project coordinator to head up this project, as well as fencing.

Lastly, replacing fencing that is at risk for failure should be addressed once open areas are first closed.

I hope you will consider these priorities as you consider the funding before you.

Dear Mr. Thornley:

The Housing Authority of the City of Reno (RHA) is in receipt of your email purporting to terminate the City of Reno's Coronavirus State and Local Fiscal Recovery Funds Subrecipient Agreement with RHA for the acquisition and development of the Bonanza Inn. As your partner in affordable housing development, RHA staff was dismayed to receive this notification without prior discussion and given the fact that staff from the City of Reno's Housing and Neighborhood Development Department recently attended RHA's February 28, 2023, Board meeting where Commissioners reaffirmed their standing directive to proceed with this project. Further, while you contend that you decided to terminate the Subrecipient Agreement because RHA allegedly received a "considerable increase in state funding," and RHA failed to meet the reporting requirements set forth in the Subrecipient Agreement, you invoked the no cause termination provision of the Subrecipient Agreement as the basis for the purported termination.

I want to note that your contentions regarding funding and reporting are unsupportable and specious. RHA primarily received State of Nevada Home Means Nevada Initiative (HMNI) funds to preserve our community's public housing properties. The assertion that RHA should suffer termination of the Bonanza Inn development due to receipt of funding unrelated to that development callously ignores the mission and purpose of RHA, to provide fair, sustainable, quality housing in Reno that offers a stable foundation for low-income families; a mission directly aligned with the City's overarching goal of providing affordable housing. To be sure, your allegation that RHA's receipt of state funding to further that mission somehow breaches an agreement to provide additional affordable and workforce housing at the Bonanza Inn is spurious and warrants no further discussion aside from a plain statement that RHA has done nothing other than operate in the best interests of all those it can serve.

As to your contention that RHA failed to provide mandated reports on the Bonanza Inn, in the staff report to the City Council you note that on March 9, 2022, the Council approved affordable housing projects at

Predominantly federally funded, the RHA has provided affordable housing for qualifying residents of Washoe County for more than 75 years. We help ensure nearly 9,000 Nevadans have a safe, secure place to call home through Housing Choice Vouchers, public housing and affordable market-rate properties. RHA is a large part of the affordable housing solution in the Truckee Meadows.

Scott Manor and Bonanza Inn, both of which are RHA projects. Following that approval, City staff engaged in myriad communications with RHA staff, including the provision of mandated report templates and attendant requests for, and discussions about, reports related to Scott Manor. Indeed, the City compliantly provided report templates regularly on the Scott Manor project.¹ Conversely, at no point did the City provide a report template on the Bonanza Inn to RHA or contact RHA to indicate a report was missing. Your contention that RHA failed to comply with the contractual obligation to report to the City blatantly ignores the City's failure to provide the required templates for such reporting. RHA could not supply such reports without the City's provision of the necessary report templates. That fact is highlighted by the proliferation of such templates and reciprocal reports related to Scott Manor.

RHA'S Board of Commissioners met on February 28, 2023, and reaffirmed its standing directive to acquire the Bonanza Inn in reliance on the Subrecipient Agreement and in furtherance of its mission in common with the City of Reno to provide the area with affordable housing and economic development. In fact, I had been preparing notification to your office on the Board's continued desire to pursue this development when the termination was received. In application, your purported termination of the Subrecipient Agreement will thwart RHA's ability to use public and private financing to develop workforce housing units within the Bonanza Inn. As you know, and as directed by the Reno City Council, this housing would be developed in compliance with regulations for the American Rescue Plan Act State and Local Fiscal Recovery Funds (ARPA SLFRF) and rent targeted to households with incomes between 60-120 percent of HUD area median income, adjusted for family size, all in furtherance of the Reno City Council's allocation of \$6,000,000 to RHA for that purpose.

RHA, based on recent, new information, intended to track the probate process of the Bonanza Inn as part of pursuing acquisition and purchase the Bonanza Inn ahead of the December 31, 2026, deadline set forth in the Subrecipient Agreement. Your termination of the Subrecipient Agreement has obviated that intention as well as any opportunity for RHA to request to divert the funds allocated to the Bonanza Inn to other RHA affordable housing developments as previously discussed with staff. It is not coincidental that your unilateral termination immediately precedes the Reno City Council March 8, 2023, meeting agenda item D.5 regarding presentation, discussion, and potential direction to staff regarding the allocation of the remaining State and Local Fiscal Recovery Funds received by the City of Reno through the American Rescue Plan Act.


RHA continues to appreciate the support it receives from City Council and is disappointed that, as a result of this purported termination by staff, we cannot work in partnership to bring much needed affordable and workforce housing to the downtown core. We understand the City has many needs and limited resources and Council may have to re-evaluate funding priorities. However, RHA does not concede or admit your alleged basis for termination and must clarify not only its good faith compliance with the Subrecipient Agreement, but also its unwavering commitment to provision of fair, sustainable, quality housing. Your move to terminate the Subrecipient Agreement directly harms that commitment, and it is my hope that the Council will reinstate the commitment to the Bonanza Inn affordable housing development. To that end, I have copied the Council members on this correspondence. I request this
