I am in favor of appealing the Planning Commission's decision to approve the 'Aspire at North Hills' development. North Hills Blvd. cannot adequately handle the traffic demands (especially during morning/evening commutes) and adding 192 more housing units with an estimated 500 residents on that road will not help alleviate the traffic issues. I am not a 'NIMBY' and have no issues with growth as long as critical infrastructure issues are addressed before construction of additional housing units starts. If the widening of North Hills Blvd. to 4 lanes was completed before construction starts, then I understand how it could make sense to approve this project. Waiting 3-7 years for North Hills Blvd. to be widened is unacceptable and will mean additional traffic due to construction in the area (between the new housing units and the the road widening) for the next 7+ years.
