RESOLUTION DONATING COUNCIL DISCRETIONARY FUNDS TO THE NORTHERN NEVADA CHILDREN'S CANCER FOUNDATION TO SUPPORT THEIR MISSION TO ENHANCE THE QUALITY OF LIFE FOR CHILDREN WITH CANCER AND THEIR FAMILIES BY PROVIDING FINANCIAL ASSISTANCE AND COMPASSIONATE

SUPPORT PROGRAMS IN THE AMOUNT OF \$1,000. (GENERAL FUND)

WHEREAS, the City of Reno may donate funds in accordance with NRS 268.028(01), entitled "Expenditure of public money; grant of public money and donation of certain property to certain nonprofit organizations or governmental entities" when such expenditure provides a substantial benefit to the inhabitants of the City; and,

WHEREAS, the Northern Nevada Children's Cancer Foundation helps alleviate the financial burden childhood cancer places on northern Nevada families by assisting with medical expenses such as insurance copays and deductibles, uncovered procedures, medication costs, and other out-of-pocket medical expenses through their Family Assistance Fund; and,

WHEREAS, the Northern Nevada Children's Cancer Foundation provides emotional support programs at no cost to families of children with cancer; and,

WHEREAS, the Northern Nevada Children's Cancer Foundation provides tools for children to succeed academically and stay socially connected when isolated due to compromised immune systems and demanding treatment schedules through their E-SMART program; and

WHEREAS, the Northern Nevada Children's Cancer Foundation advocates for important childhood cancer issues before Congress by raising awareness to key issues with legislators on Capitol Hill; and,

WHEREAS, the Northern Nevada Children's Cancer Foundation contributes to childhood cancer research by hosting fundraising events and running awareness campaigns; and,

NOW, THEREFORE BE IT RESOLVED that the City of Reno approves the Council donation from Councilmember Reese in the sum of One Thousand Dollars (\$1,000) to the Northern Nevada Children's Cancer Foundation; and,

BE IT FURTHER RESOLVED, that should the above donation or any portion thereof not be used for the purpose as set forth in this Resolution, any unused funds shall be returned to the City of Reno.
