With respect to the final report of the Virginia Street Urban Placemaking Study being presented to City Council on April 12th, I would like to respectfully urge the Council NOT to adopt the implementation phases as presented at this time. Many of the recommendations, most prominently the suggestion of removing a turn lane, slowing traffic, and adding bike lanes to the central portion of Virginia Street, warrant far more analysis and community/business owner buy-in, particularly as a Reno Gazette-Journal article published just this morning includes many concerning revelations about the pausing of the Center Street Cycle Track and the push to install bike lanes on Virginia.

Ky Plaskon with the Truckee Meadows Bicycle Alliance. While the Truckee Meadows Bicycle Alliance applauds design elements of the Placemaking study as a game changer for Reno, there is one major flaw and we must regretfully oppose the report (item D4), not for what it includes, but for what it omits. The City of Reno Staff must follow through with a commitment not only to the Truckee Meadows Bicycle Alliance as a major stakeholder in this project but also to the community in the spirit of public safety.

In meetings with City Staff, the Truckee Meadows Bicycle Alliance was told that the Placemaking study would consider the Center Street Cycletrack. However, it is only mentioned once in the entire 143-page report. The placemaking study showed that the overwhelming majority of respondents want safety downtown now, however, the report does not make a recommendation on this downtown safety project that is already in the works.

The City of Reno Council should reject this report in its current form as city staff did not follow through on their commitment or the spirit of the report to improve downtown safety. Please ask city staff to come back with a report that includes a

recommendation on the Center Street cycle track and how it fits with safety and placemaking downtown.

It is time the City of Reno Staff lifts their opposition to this major downtown safety improvement project. A sense of place means safety now, not years down the road. If we are going to have a safe downtown and be a bike-friendly city, the city needs to finish what it started with the Center Street Cycle Track.

It's unsettling that a bike path safety project that was decades in the making and studied heavily is shut down by politics and free parking. We need to stand up against this antiquated way of thinking if we are going to make progress to be a safer and healthier city.

Our city leaders need to do what is right and follow what the public said it wants in this study: safer streets now. We need to stop putting our families, children, students, and workers in danger. We have been patient. Please complete the Center Street Cycletrack and at the very least include it in the Placemaking study as city Staff committed it would be. The studies show the Center Street Cycletrack is a sure bet and we can finish it now while you study and explore improving safety on Virginia St as well.
