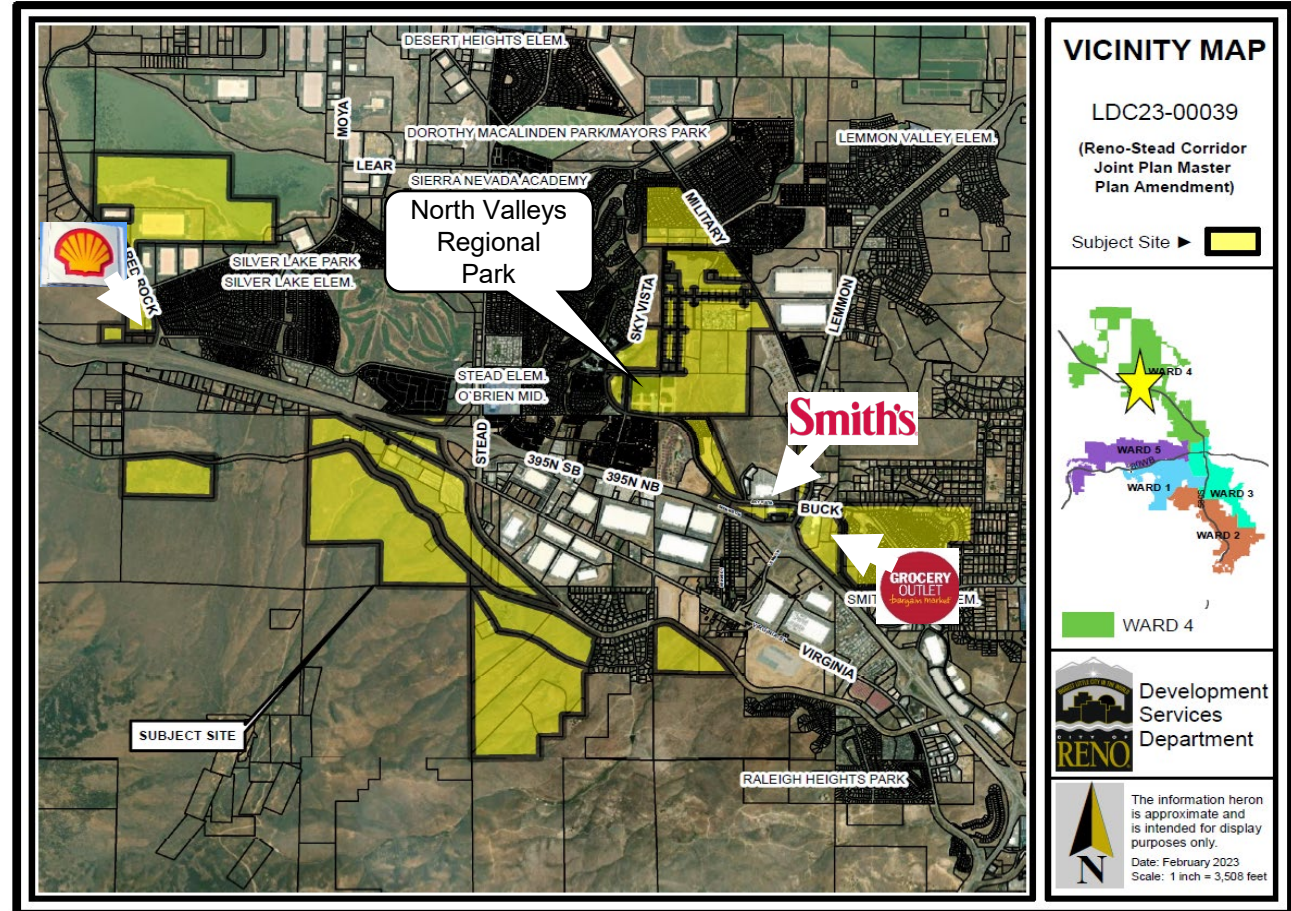

Project Details

- In 2017 - Relmagine Reno Master Plan highlighted sunseting the Reno-Stead Corridor Joint Plan
- 2019 - Truckee Meadows Regional Planning
- 2020 - Washoe County
- 2023 – City of Reno



Boundaries of the parcels designated within the Reno-Stead Joint Plan

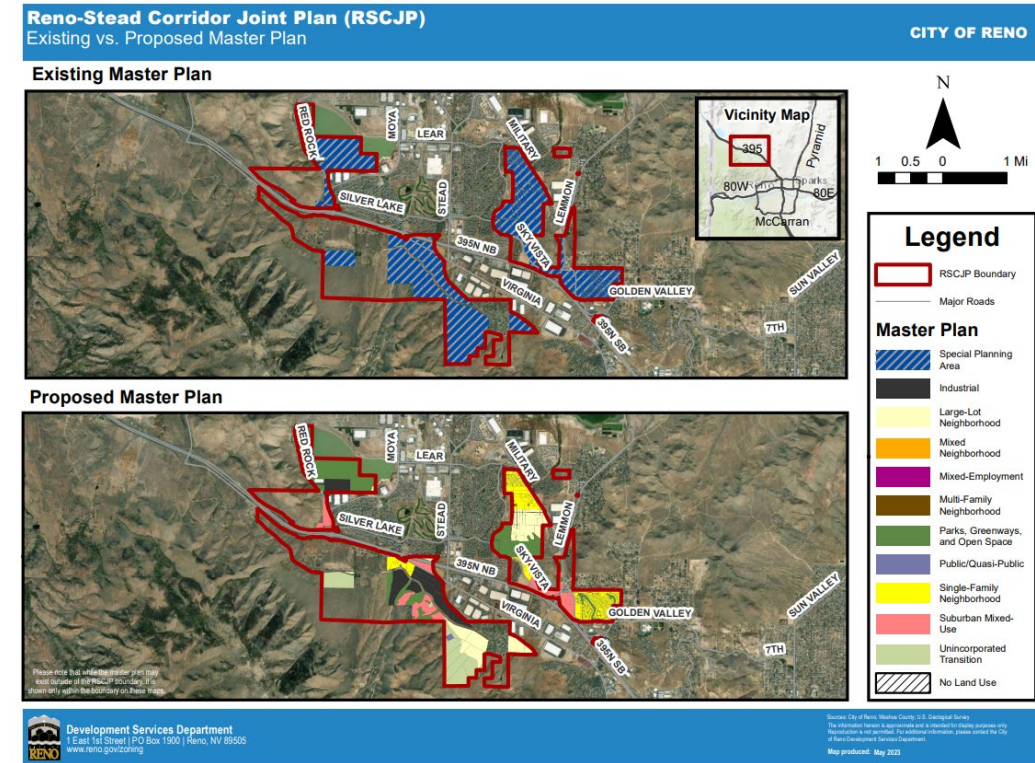
What was the Reno-Stead Corridor Joint Plan?

- Joint document between Reno and Washoe County
- Intended to guide future growth in the North Valleys area over a 20 year period.
- ±4,309 acres
- Located between Red Rock Road and Golden Valley Road
- Developed to guide orderly growth and development, while protecting natural resources and providing public services
- Established Master Plan designations within the Joint Plan Area
- Required approvals by both Washoe County and the City of Reno through joint public hearings.



Request for a Master Plan Amendment

- Sunset the Reno-Stead Corridor Joint Plan (RSCJP)
- Change all existing Master Plan land use designations on 1,160 parcels to City of Reno Master Plan designations
 - Truckee Meadows Regional Planning sunset the plan in 2019.
 - Washoe County sunset the plan from their Master Plan in 2020.

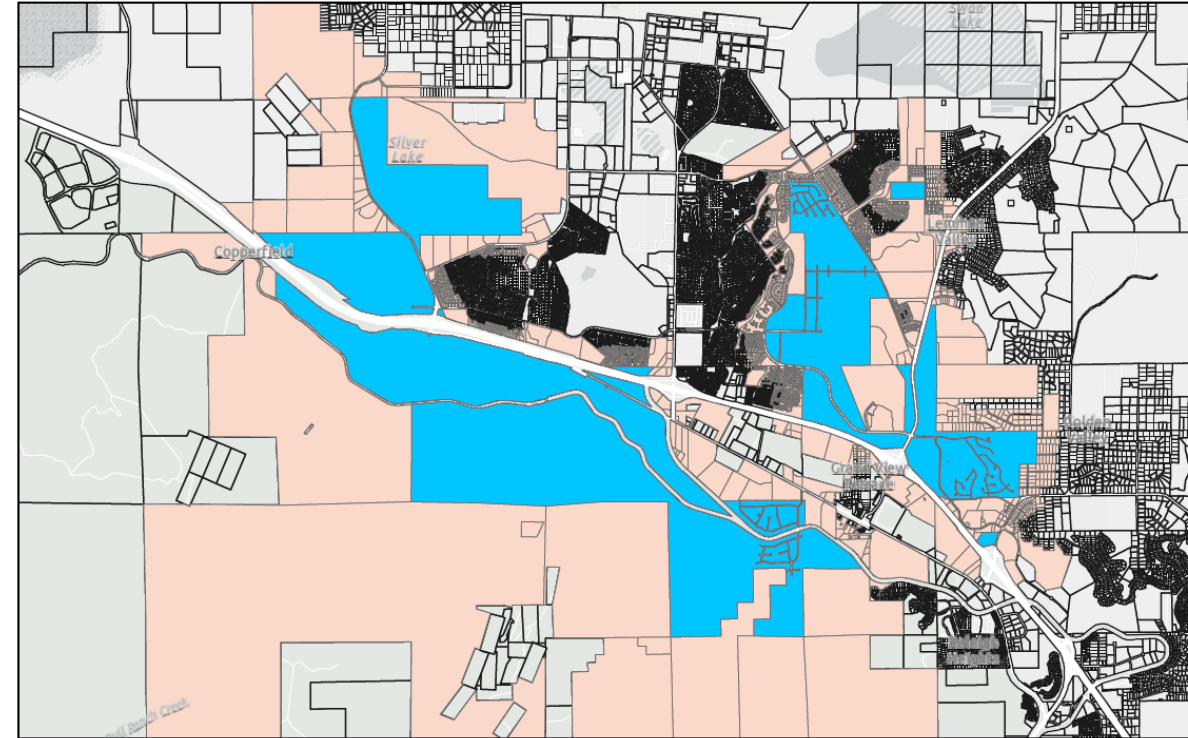

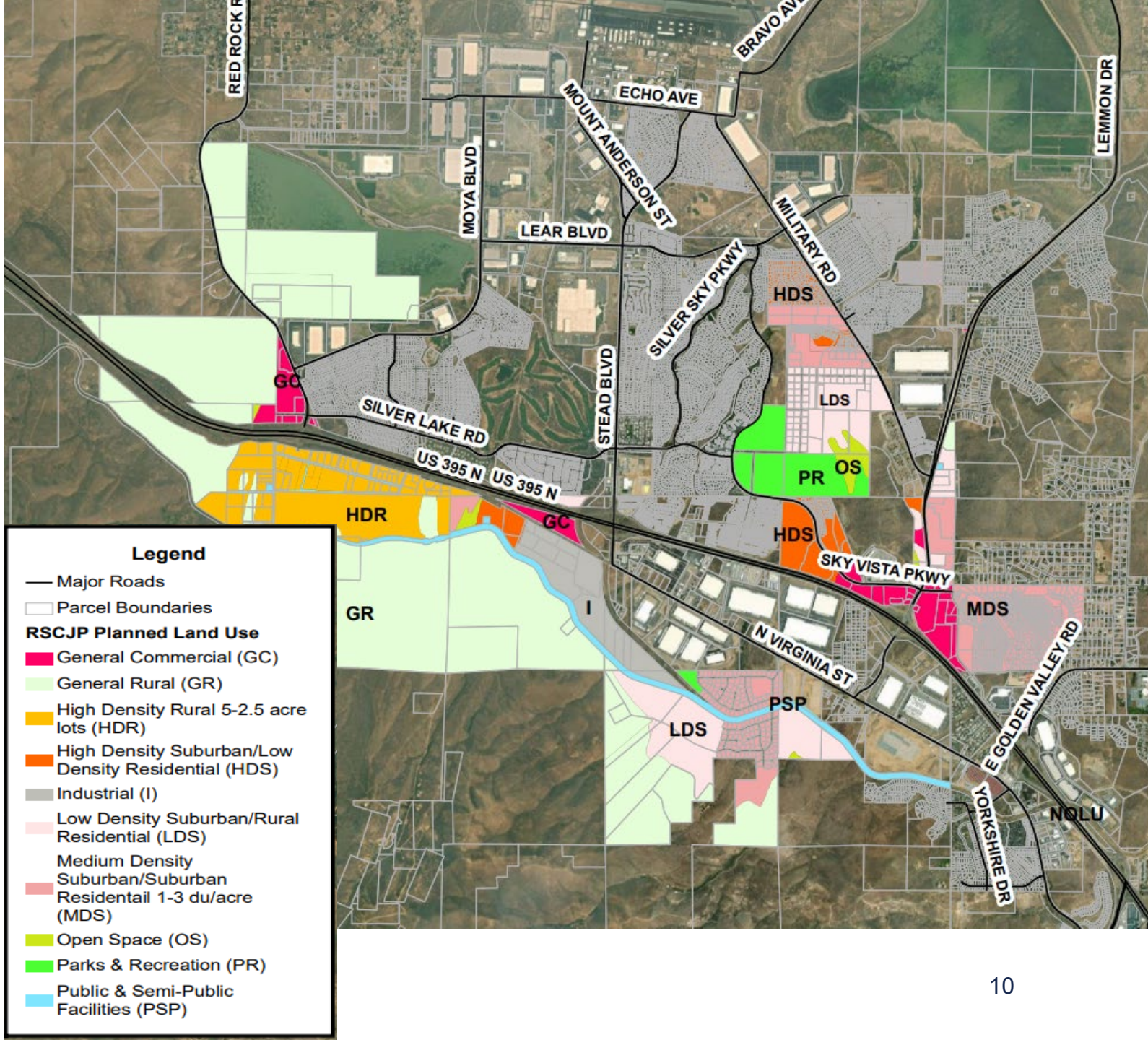

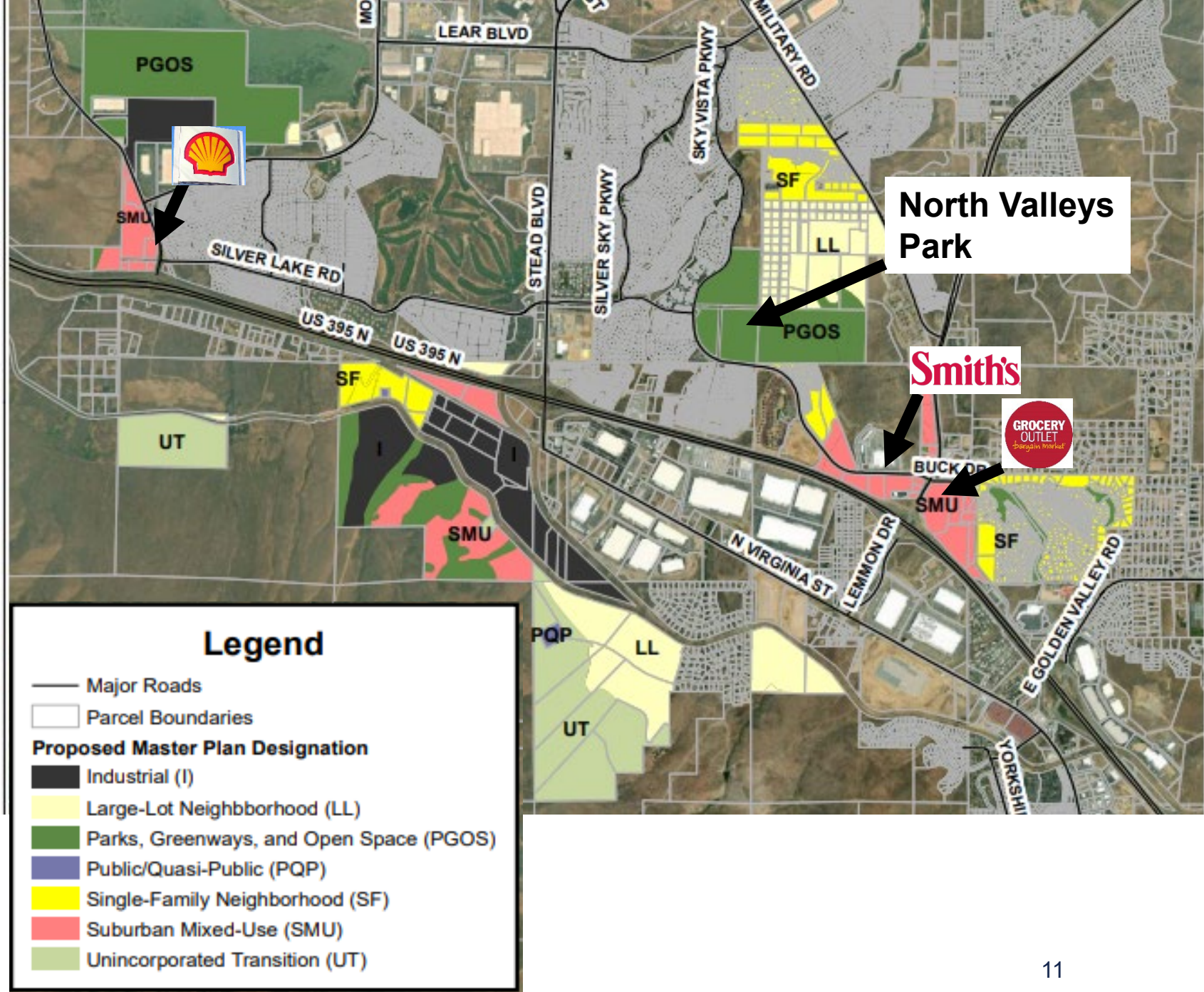
RSCJP Planned Land Use:

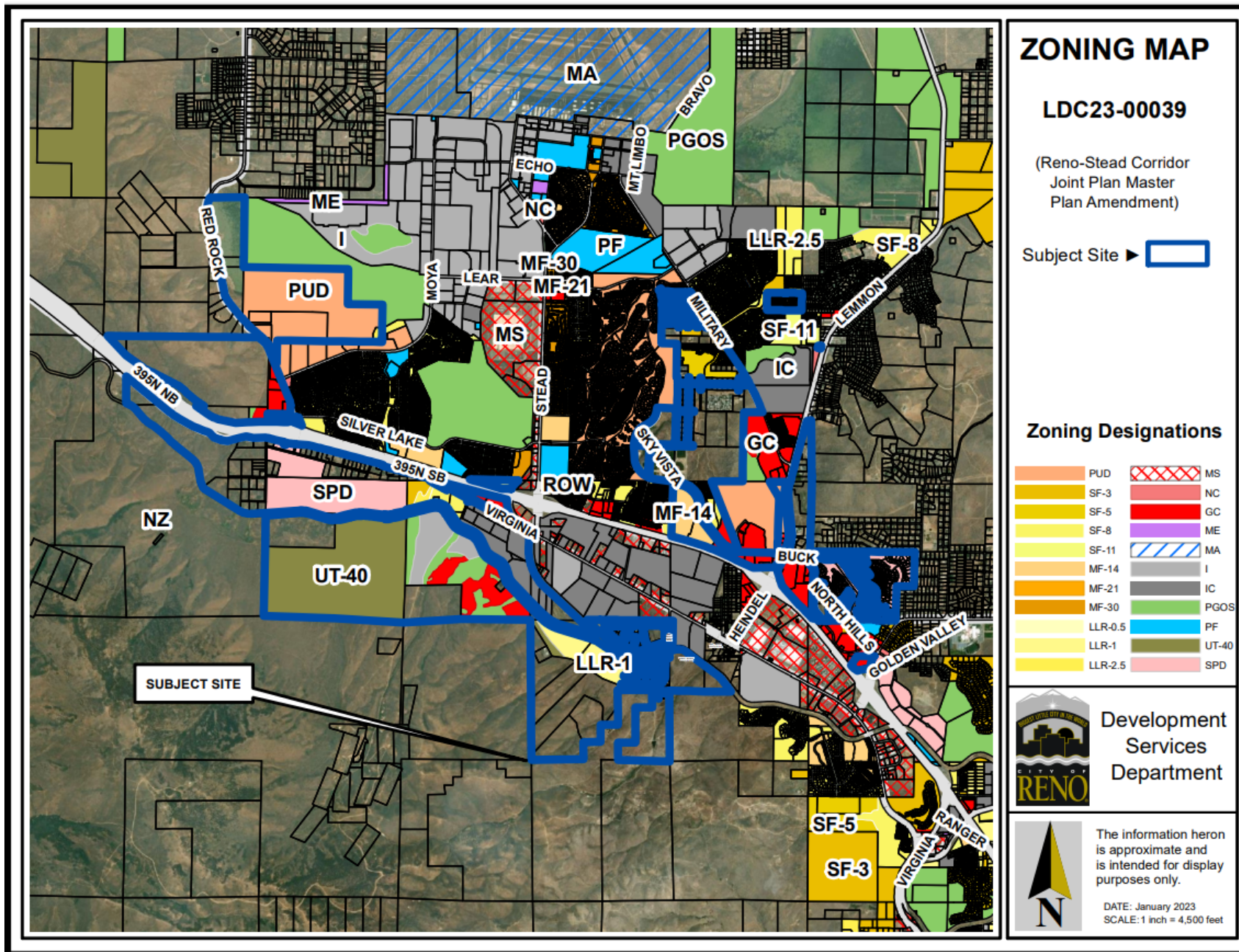
- This map was provided in the Joint Plan and identified where commercial, industrial and residential land uses were planned to go.
- This was the original intention for growth and development.

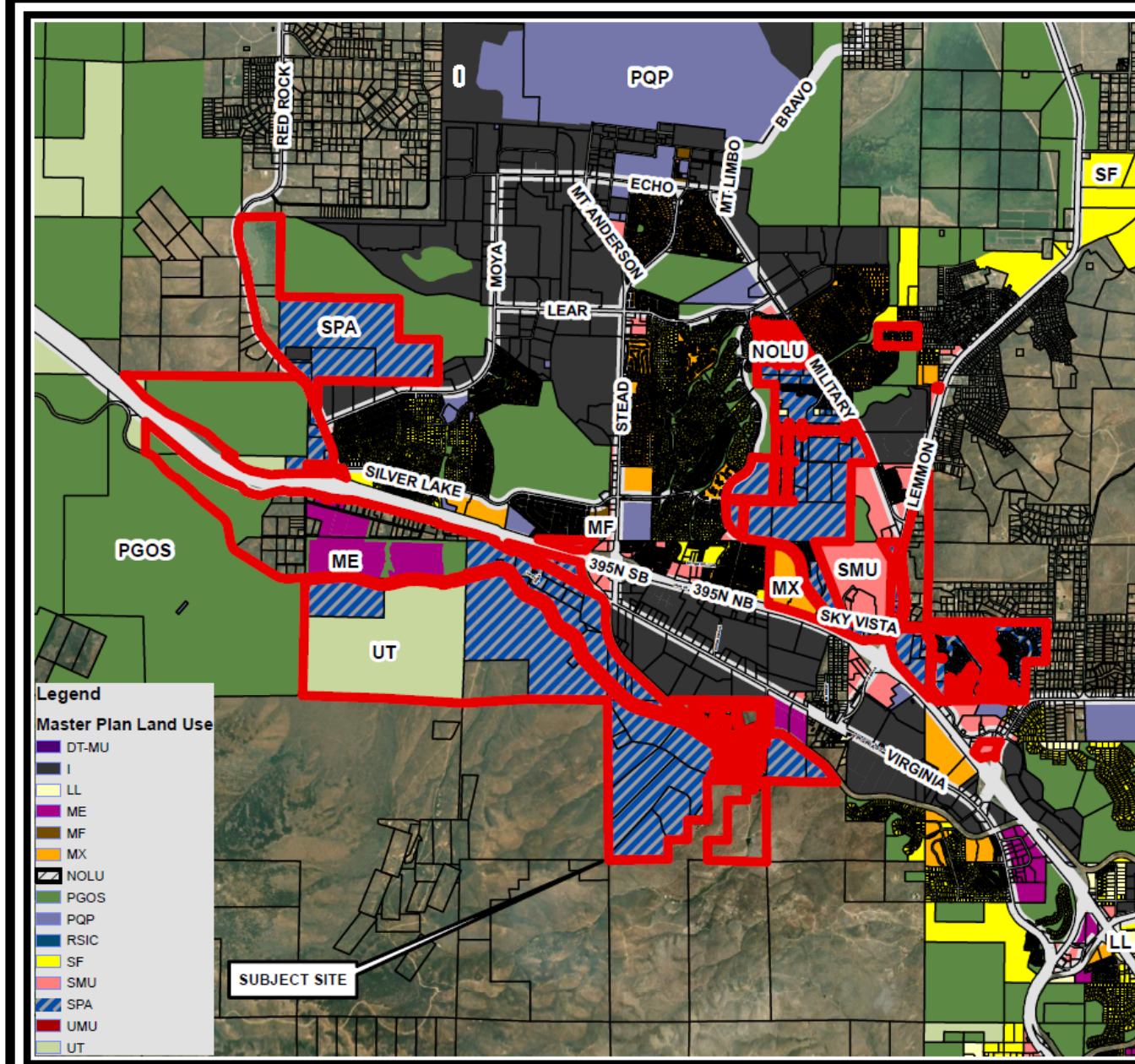


Proposed Master Plan:

- Overall, this map matches existing development and zoning.





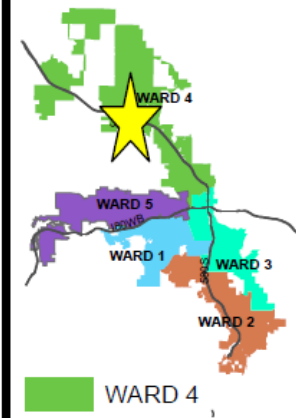


MASTER PLAN MAP
