

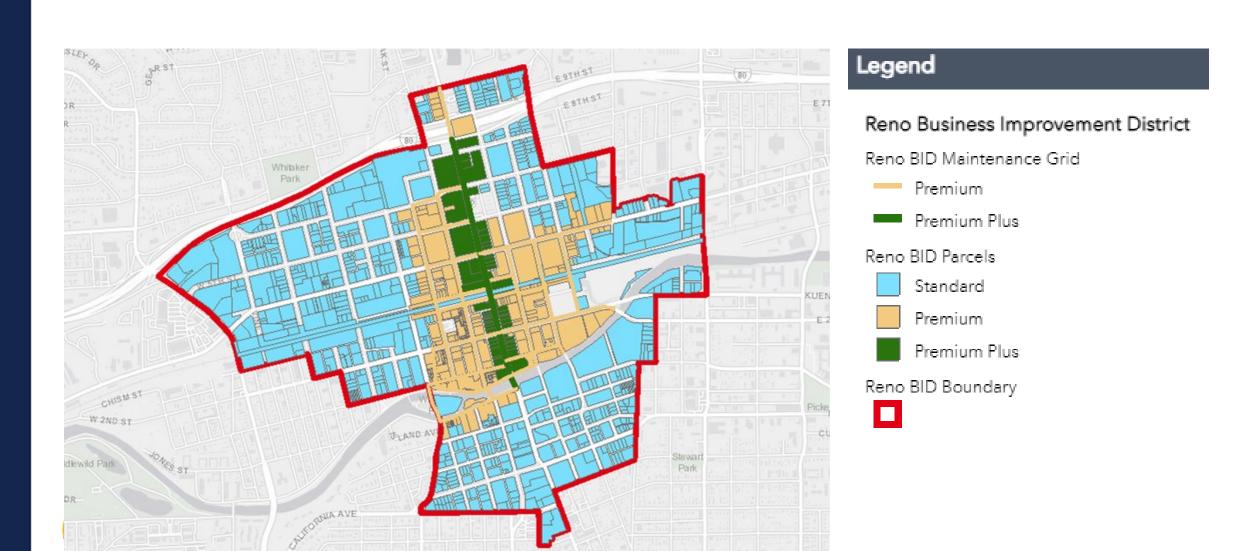


### **BID Assessment Process**

- 1.Public Hearing on any Complaint, Protest or Objection to the Assessment Roll
  - Review and determine hardship applications (per NRS and Ordinance 5385)
- 2. Resolution Introduction
  - Dispense or accept any objections to changes to the proposed assessment role
  - Ratify the project cost
  - Confirm assessment roll
- 3. Ordinance Introduction

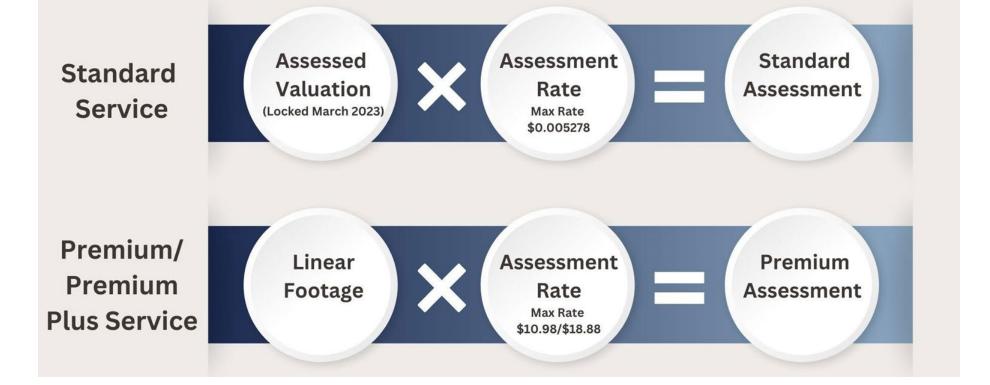

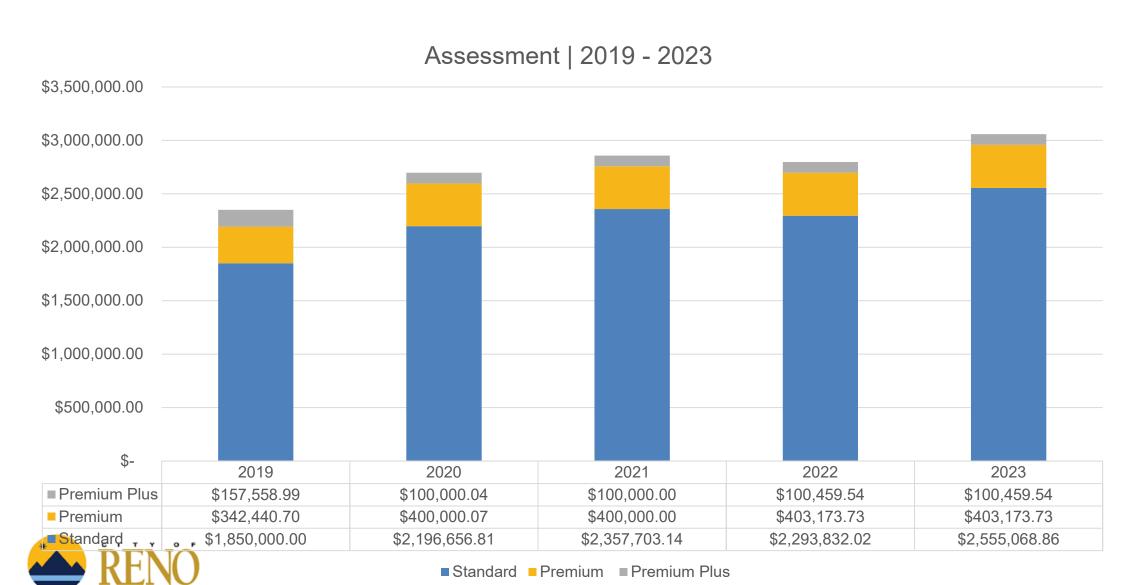

# Public Hearing and Hardship Determination - Item C.1.1

Staff recommends approving the ten (10) hardship requests.



## Resolution Approval – Item C.1.2

I move to approve the Resolution of the Reno City Council dispensing with certain complaints, protests and objections made at the public hearing on the assessment roll for a City of Reno, Nevada Neighborhood Improvement Project, otherwise known as the Downtown Reno Business Improvement District; ratifying the cost of the project; and confirming said assessment roll and the assessments therein <u>including the ten hardship exemptions</u>; to authorize the recordation of properties to be assessed in the Office of the County Recorder; together with other matters properly relating thereto.



## Ordinance Introduction – C.1.3
