## **RESOLUTION NO.**

RESOLUTION OF THE RENO CITY **COUNCIL** AMENDING RESOLUTION NO. 9052, ADOPTING AN AMENDED SALARY SCHEDULE FOR UNREPRESENTED HOURLY **EMPLOYEES** NOT **COVERED** BY AN **EMPLOYEE-MANAGEMENT AGREEMENT CONTRACT** OR **COLLECTIVE** BARGAINING AGREEMENT **TWO-AND-ONE-HALF** REFLECTING Α PERCENT COST-OF-LIVING INCREASE, AND ADOPTING **CORRESPONDING SALARY INCREASE FOR AFFECTED** EMPLOYEES, TO COST \$118,387 FOR THE CURRENT FISCAL YEAR; TOGETHER WITH OTHER MATTERS **PROPERLY RELATING THERETO.** 

A. WHEREAS, the Reno City Council (the "City Council") desires to provide, by resolution, for a cost-of-living increase for regular unrepresented hourly employees hired pursuant to Sections 1.090 and 3.060 of the Reno City Charter (the "Charter"), who are under the direction of the City Manager or the City Attorney (the "Unrepresented Hourly Employees"); and

**B.** WHEREAS, Unrepresented Hourly Employees are not subject to an employee- management contract or bargaining agreement; and

C. WHEREAS, the current Unrepresented Hourly Employee salary schedule was established for said employees by Resolution No. 7855, amended by Resolution No. 8232 and by Resolution No. 8488, amended by Resolution No. 8755, amended by Resolution No. 8922 and further amended by Resolution No. 8999; and

**D. WHEREAS,** the Reno City Council desires to increase the pay range reflected in the salary schedule for said employees; and

**E. WHEREAS,** the Administrative Code of the City of Reno, Section 2.14.020, states that "the City Manager shall establish such additional classifications as may be necessary for the operation of the City. The City Manager shall assign said classifications to the appropriate pay range and may adjust the pay range assignment of existing classifications within the limitations of current budgets and the salary schedule(s) adopted by City Council."

**NOW THEREFORE** be it hereby resolved by the City Council of the City of Reno as follows:

Section 1. The City Council hereby finds that the foregoing recitals are true and correct and are incorporated by this reference.

Section 2. Resolution No. 8999 is hereby amended by replacing the salary schedule attached thereto with the salary schedule attached hereto as Exhibit "A", which reflects a two and one-half percent salary increase affecting Unrepresented Hourly Employees, to be

implemented effective July 14, 2023.

**Section 3.** The Mayor, City Manager, members, officers, employees and agents of the City are hereby authorized and directed, jointly and severally, to do any and all things and to execute, deliver and record all documents as may be required and otherwise to give effect to, carry out and comply with the terms and intent of this Resolution, and to take all necessary and appropriate actions to effectuate the intent of this Resolution.

Section 4. This resolution shall take effect immediately upon its passage.
