I am a highly motivated leader with years of professional experience in government and transportation. I will bring to the Reno Tahoe Airport Authority a unique perspective from managing the Nevada Department of Transportation's diverse financial and administrative operations, including its Flight Operations Division. At the City of Reno, as the Director of Finance and Administration for the City of Reno, and most recently as Vice President of Finance and Operations for the RSCVA, I have had the privilege of managing the finances of these important agencies. This brings a perspective of having knowledge and firsthand insight into the importance of the Reno Tahoe Airport to the community.

I have worked closely with elected officials in both formal and informal settings, including City Council members, constitutional State officers and key members of the State Legislature. In my prior position with NDOT, I worked closely with federal representatives from such agencies as the Federal Highway Administration, Federal Communications Commission, Federal Aviation Administration, and had periodic interactions with members of Nevada's congressional delegation and their respective staffs.

I am well versed on all aspects of governmental finance including an indepth knowledge of government bonds. I successfully managed the issuance of over \$1 billion of bonds at NDOT, while improving the Department's bond rating. While at the City of Reno and at the RSCVA, I refinanced, restructured, and improved the debt portfolios.

Further, the undersigned acknowledges that he may at any time withdraw both this waiver and related application for appointment.


