## Interests & Experiences

Besides having a personal love and interest in Reno that dates back to the 1970s. I have around 20 years' experience researching many various aspects of Reno history. Also 37 years of genealogy experience, and 3 years' experience working as a Private Investigator doing "locates". History and research have been a lifelong passion of mine. I've been very active in many aspects of Reno History. I've been a member of the Reno Historical Society, and was involved with their efforts to save the historic gateway homes on Center street. Also was a volunteer for the "Harvest of Homes" tours. I have created, and run, multiple Facebook groups regarding the research I've done, and continue to do on Reno History, as well as Lovelock Nevada History. Facebook Group "Old House Lovers: Homes & Histories of Northern Nevada" : As a Reno Realtor I specialized in the older homes. I would research the homes' histories, as well as the families that lived in them. Then I'd give a copy of my research to the buyer and sellers. This led to starting a Facebook Group where I would share the information, and stories. People submit their requests for homes they would like me to research for them. Its been a great Reno history learning experience. Facebook Group "History: Nevada Hospital for Mental Diseases (Nevada Insane Asylum)": Currently I've been researching the history of the Nevada Hospital for Mental Diseases (The Nevada Insane Asylum). The current memorial for the Asylum Cemetery has 767 people listed, with an estimated 400 additional people buried there whose names were thought lost to history. So far I have

found around twelve additional people whose identities were thought "lost to history". Facebook Group "The Pink House - Lovelock, Nevada": I purchased a house in Lovelock, Nevada that has sat abandoned for a little over 30 years that I am fixing up. It's affectionately known as "The Pink House " which was built in 1914. It was the first mayor of Lovelock, and Seven Troughs mine owner's home. I have done extensive research on this home and all the previous owners as well as documenting the work on the house. Facebook Group "History of Lovelock Nevada ": This hosts many aspects I have researched and posted regarding the history of Lovelock Nevada. From topics to include Winnescheika, the last witch to be executed in the US, to Indian like the "Paiute Millionaire", and the history of the Turrillas Family (that owned the Lake Mansion in Reno, and has significant ties to Lovelock). This group is probably my most popular with 1530 members. Almost the entire population of Lovelock. One of my best friends of 35 years is Courtney Mooney who was the Urban Design Coordinator/ Historic Preservation Officer for the City of Las Vegas for 14 years. She is now the Historic Preservation Planner/ Architectural Historian for North Wind Resource Consulting. She is originally from Carson City and Reno. She has been a wealth of knowledge for me, and someone that shares my love and passion of our state's history.

I am passionate about all aspects of this board, and would be excited to be a part of it! I am a highly motivated person and I believe I could make a positive contribution with my knowledge of Reno history and research skills.
