Interests & Experiences

Historical Resource Commission

Education or training relevant to the board or commission to which you are applying:

The history of Reno is of paramount importance to me. For the last 25 plus years, I have been preserving the iconic neon signs that personified Reno for the last century. In the 90s, Reno was losing some of the most historic properties and I thought that it was important to preserve the signs even if the buildings were destined to be demolished. History is often the collateral damage in our attempts to reinvent the City that we all love. I thought the signs were a significant part of our collective history and they should be saved. We have shared the signs at venues like Nevada Museum of Art and UNR. The collection includes signs from: Harolds Club, Nevada Club, Riverside, Mapes, The Holiday, Virginian, Parkers Western Wear, Harrah's, Merry Wink Motel and dozens more. In 2008 I was given the Distinguished Service recognition for historic preservation by the City of Reno. Ten years later, I was recognized in the Advocate category. Although the effort was not ultimately successful, I was active in the effort to save the Mapes from being demolished. In 2016 I worked with the City to preserve the signs from the Golden West Motor Lodge. I was one of the founding members of the West of Wells neighborhood group. We worked hard to revitalize the neighborhood and recognize the important historical elements. Through our efforts, in 2013 the neighborhood was officially recognized as a conservation district. In 2017, there was an effort to modernize the Reno Arch. One of the aspects of the proposal was to replace the neon with LEDs. The arch is a community treasure as well as a piece of art. The signs has been photographed

millions of times and the neon is a vital element of the sign. I worked with my Nevada Neon Project followers to vote for what they felt best represented our city's heritage. Thankfully, the vote was to preserve the neon elements of the sign. In 2019, I worked with Northern Nevada elementary school children to propose AB182, to recognize neon as one of our official state symbols. The bill passed both houses unanimously and was signed into law by Governor Sisolak. I truly love Reno history and believe it is vital to the strength of our city. I do not have formal historic preservation education or training, my knowledge has come from over 25 years of jumping in and doing the hard work to make sure that our history endures.

Explain briefly why you would like to be appointed to this board or commission.

The City of Reno is in a phase of great change. It is vital for the success of our city to protect it's historic resources. The majority of my preservation work has been on the micro level, once decisions have been made to demolish properties. I look forward to working with a passionate and effective group of individuals with diverse backgrounds to collaborate on a macro level to develop plans and initiatives to protect our cultural heritage. Being a Reno native with experience in historic preservation, I feel like I can contribute a specific perspective that will be helpful in discussions about prior preservation efforts. I look forward to learning from other Historic Resources Commission members, and City representative Megan Berner, about Commission successes and challenges. I hope to be a part of this commission to help ensure that historic resources are an integral part of Reno's path forward.
