<b>Your Comment (if you are speaking, it is not necessary to complete this field)</b>	<p>I am in support of parking permits for the Putnam/Creighton neighborhood. Our neighborhood streets at the east end of Putnam are being used as a parking lot by students who don't live in the neighborhood. Our neighbors can't park their cars in front of their own houses. Their mailboxes get blocked. The street sweepers can't remove debris and trash collects around the cars. The Torvinens at the end of street had big tree limbs downed in last winter's ice storm, but were unable to get a truck parked near enough to their yard to remove the branches for months. The parking situation will likely get worse for us as more of the student housing is completed. Living by the university still pretty much requires a car, so students bring their cars, but their new housing does not provide enough parking. That's an issue that local governments will need to address, but in the meantime, the neighborhoods near the university shouldn't have to be the parking lots; it negatively affects our quality of life.</p>

I am a long-time resident of the 500 block of Putnam Drive and I fully support going to residential permit parking in our neighborhood. In all the years I have lived on Putnam (25) we had UNR parking, but it was only during the day. Our neighborhood has become a 24-7 parking lot since new apartments opened up last fall. Drivers speed down our street looking for the closest spot to park and often leave their car in the same spot for weeks, sometimes blocking our mailboxes, our driveways, and even our fire hydrant. We have been pursuing this as a neighborhood for over a year. We have reached out to code-enforcement, city of Reno parking division, our council member Kathleen, Mayor Schieve, and our NAB. The traffic study conducted supports our need for residential parking. A majority of our neighbors are in support (from the survey Amy Pennington did this summer) as we are tired of all of the new traffic on our streets for parking, not being able to park in front of our own homes, having garbage left behind, and just a general disregard for our wonderful neighborhood by people that only think of it as a parking lot. Please support what our neighborhood wants. We should not have to have the burden of having numerous cars constantly on our street because of the nearby apartments being able to be built without enough parking for their tenants. ## **Putnam Parking District**

What brings myself and my fellow neighbors presenting this evening is a result of the fact that not enough parking was constructed in the nearby neighboring apartments on North Virginia and North Sierra streets for all their residents, who are primarily UNR students.

Here's what I have found out. I acquired the number of residents and parking spaces that exist at the three complexes Park Place, the Uncommon and now the Dean. They are charged \$200, \$150, and \$150 per month respectively. Approximately 1100 residents are left without an option to park where they live except on the recommended few spaces along North Virginia and North Sierra streets as an overnight option, if any are available. Even at a generous guess that 1/3 of the residents don't have a car, that's still approximately 750 vehicles without a parking space. These large apartment buildings are only required by the city to provide one parking space per unit. The units range from one bed to 6 beds.

Problems now:

- 1) 700 to 1100 vehicles need to find overnight parking and our neighborhood has been discovered as an option
- 2) cars park here for days on end; parking in front of our houses is not always available to us; trash is left behind; cars are blocking the fire hydrant, sometimes blocking driveways; and most are driving too fast. I inquired about a speed bump and was told a certain number of incidences need to occur before that happens. We have many families with young children in the neighborhood, one incident is one too many!
- 3) Resorting to permit parking is what we're looking at, which currently seems a viable solution. Although losing our freedom to have family and friends parking for celebrations and gatherings, facing getting ticketed is far from desirable.
- 4) The city's resources would still need to be spent monitoring the permits. My understanding is that volunteers are necessary to monitor street parking as it is.

## Solutions

- 1) Perhaps the city could find a solution of more parking...maybe overnight parking on campus?
- 2) Maybe the city can require more parking in the future for new construction complexes!!!
- 3) If we're not granted the permit option, it would be nice for a no parking or warning sign at the barrier at the end of our street where those parking have to pass to return to their apartment.

In closing, this parking problem isn't the fault of the students, the apartment investors and certainly not us kind neighbors. In the future, a more realistic requirement could be in place to avoid Reno's parking dilemma. I'm not a planner but the outcome of these massive construction projects is no surprise and now it remains to be patched up.

I have other friends that don't want to pay to park at UNR or at their apartments (monthly parking fees if they can get a spot are over \$100/month). Our street should not be a parking lot for people that don't live on Putnam or Creighton. Friends that used to park on our street used it as a place to park only during the day. Now they want to park there all the time because it is free and near the apartments where they live. My family is always picking up garbage that is left in our yards, or moving bird scooters off of the sidewalk, etc. It is a headache for those of us that live here to wonder where we will park when we return to our homes and what garbage we will find in our yards.
