The State Historic Preservation Office finished its HPF grant selection for the FY2023 subgrant cycle and is pleased to announce that your organization has been awarded **\$30,000.00**.

The City of Reno's request included not only survey and inventory but also the creation and review of a National Register of Historic Places (NRHP) nomination for the East Fourth Street potential district.
