As a Downtown resident with standing through living in close proximity to the J Resort, I am writing to respectfully request that the Reno City Council does <u>not</u> approve the City Attorney's recommendation to appeal the Second Judicial District Court's decision from September 23, 2023 to prohibit the erection of two of three signs promoting the so-called "Neon Line District".

I request this with no animus towards Jacobs Entertainment. From a business perspective, I can understand the promotional strategy of that private organization to want a District all to themselves.

My reasons for <u>not</u> wanting the City Attorney to appeal the September 23 decision by the Court are:

- I agree with the Judge's reasoning that two of the signs do not serve the purpose of area identification, and that one of them is larger than is allowed by the RMC.
- Again, not picking on Jacobs Entertainment, but I do <u>not</u> agree with allowing private organizations to name areas of the City of Reno without direct Resident input. There are still many organizations and private property <u>not</u> owned by Jacobs Entertainment in the area that organization wants to designate as its "Neon Line District". I think allowing them to do so sets a bad precedent.
- When deciding something controversial like a private organization wanting to name a City District, I
 have always believed that the City should have a referendum. While our system of representative
 democracy leads residents to cede some amount of responsibility to the City Council to make
 decisions, if there are the survey tools available to ask for direct public input, I believe the City should
 use them.
- In recent years, the Council has decided <u>not</u> to appeal Court decisions in favor of Development interests, most specifically in the Verdi area. In those cases, the rationale was financial (cost of losing the appeal) rather than ethical (the City had had its own decisions overturned, and still felt they were correct).
 - In the case of the "Neon Line District" decision, I find no compelling benefits to the <u>City of Reno</u> that would accrue if a City appeal was successful. I would then, rather that the City <u>not</u> appeal the Second Judicial Court's decision to deny a private organization's request for signs.
- In terms of a financial reason, I would prefer that any costs related to an appeal by the City Attorney
 be spent on more policing Downtown, a much more important and Resident-affirming way to spend
 budget dollars.

No one knows what the State Supreme Court will do in an appeal. But we know that if you appeal the judge's decision in Scenic Nevada's lawsuit, we will do what we always do – and that is fight for the law adopted by our citizens who voted to ban billboards in Reno.

We are drop dead serious about protecting the ballot initiative and as you may be aware we have been as vigilant as possible when it comes to billboard and sign control given that Scenic Nevada is a non-profit staffed by volunteers.

Mayor Schieve, on behalf of the city, you signed the 2017 billboard Settlement Agreement between the city, Scenic Nevada and Lamar Advertising to enforce the peoples' vote to ban new billboards.

You, and Council Members Jenny Brekhus and Naomi Duerr showed great leadership during that time and refused to be cowed by the billboard industry. Remember what was said by Council Member Duerr in those 2017 meetings, "No (billboards) means no." Mayor Schieve, you and the rest of the council have an obligation now to be fair and honor our agreement.

Referring to our Settlement Agreement, District Court Judge Connie Steinheimer pointed out in her ruling that "[A]n implied covenant of good faith and fair dealing exists in all contracts."

We think when you approved the 2021 Development Agreement that included the Neon Line District signs, you listened to those who thought they had a clever work around to the billboard ban and our city's sign codes. To us that represents a failure on your part to uphold the 2017 Settlement Agreement, which is a contract like any other.

Judge Steinheimer, following the law as she views it, ruled that you are prohibited from granting building permits for the Cemetery and Gas Station signs, leaving the 2021 Development Agreement between the city and the Neon Line developers intact, along with the Archway sign.



The Cemetery sign would not have been located within the Neon Line District, but three-quarters of a mile away facing the freeway, advertising to passing drivers. We said it cannot possibly be considered an area identification sign and that it fits the definition of a billboard. The judge agreed. She called it what it was, a billboard. We said the 25-foot-tall Gas Station sign was prohibited by city codes and the judge agreed. City code limits signs at the proposed location to eight feet. The Archway Sign was assigned casino sign regulations in the Development Agreement that are allowed in the gaming overlay district. Part of those regulations include a location requirement – only casinos can take advantage of the intense signage allowed. The archway sign will not be located on a casino property, but across four-lanes of traffic on Fourth Street, a public road, advertising Jacobs Entertainment's trademark, "Reno's Neon Line District." Even though the judge did not agree with us, we think the Archway sign is an off-premises advertising display – a billboard – under City code.

Now, you have a choice to make. Uphold the people's vote and the Settlement Agreement or appeal the judge's ruling and keep arguing that off premises advertising displays are not billboards, an argument that flaunts City code.

We hope you will keep the promise that was made in the Settlement agreement now and in the future - that billboards can only be erected in the city limits by surrendering a banked receipt and meeting all the other billboard requirements. Do not break faith with us and the people who support you and voted for the billboard ban. Uphold the law.

I have lived in Reno for more than 30 years and while I support growth and development, especially in the downtown area, there are some comments I would like to make concerning two items on the agenda.

First: Item B.21 – **A vote to accept** a grant from the Nevada State Historic Preservation Office to survey and inventory East 4th Street properties is a positive step towards mitigating growth by honoring our history and expanding our definition of development to include both new and preservation development. Recognition and conservation of our historical landmarks is an important value. Both types of development, new projects and conservation projects, would be appealing for our tourist industry, for our residents, and for future growth.

Second: Item D-1 – **A vote to deny** appealing the order of Judge Steinheimer permitting only the one Archway Sign seems the right choice in my opinion. This is the only one that appears to be an Area Identification sign and one that will not intrude on the public areas. Although my hope is that future actions will challenge the use of this specific type of sign, spanning the entire street. After some reading, it seems appropriate that an Area Identification Sign be an **on-premises sign** for some or all of the properties in that area owned by Jacobs Entertainment. The entire region is not part of that company's development plans. Moreover the phrase "Reno's Neon Line District" has been trademarked by Jacobs Entertainment and will explicitly advertise the company's gaming and entertainment projects. Using public areas to advertise the private sector seems wrong to this resident.

The Reno City Council ought to DENY the request of the staff report to appeal the Decison & Order of District Judge Steinheimer in Case No. CV21-02086, styled as "Scenic Nevada, Inc. -vs- City of Reno, et. al." Judge Steinheimer is one of the most seasoned and respected District Judges in Nevada, and her 18-page Order, filed September 22nd, 2023 is very likely to be affirmed by the Nevada Court of Appeals and/or Nevada Supreme Court. To vote to spend additional public resources including lawyers and staff salaries of the City Attorney's Office is unreasonable, and contrary to the interest of the people of Reno who pay those salaries with their taxes. The Court's findings and decision that at least 2 of the proposed gaudy "NEON LINE" signs would violate the existing law that prohibits additional billboards, is certainly based on both fact and law. Because the Court is spot-on correct in concluding these two signs are NOT "Area Identication Signs" but rather, a "billboard" and an on-premise sign that would violate the 25-foot limit of the City Code. There has never been a downtown district called: "RENO'S NEON LINE DISTRICT." That phrase is simply the creation of a clever marketing agency for the developer. Now we learn that this phrase was invented AND TRADEMARKED WITH THE U.S. PATENT & TRADEMARK OFFICE, by the developer on November 1st, 2018 as "Standard Character Mark # 88177645." In other words, the phrase "Reno's Neon Line District" is no different that "Coca Cola," or "Best Buy," or "Sears & Roebuck." Would this City Council have allowed the area on West 4th Street to be named the "Best Buy District" and permitted the developer to erect billboards advertising it as such? I think not. I urge the Council to not only DENY the City Attorney's office permission to appeal Judge Steinheimer's Order. But also, I request the City Council to rescind and revoke its approval of the so-called "Archway Sign" proposed to span four lanes of traffic on West Fourth Street, because the application for its construction was made on false and misleading arguments, without disclosing to you the truth: that the phrase "RENO'S NEON LINE DISTRICT" was simply invented and indeed, patented or trade-marked, as a clever way to convince you that there is actually a district by that name. There is NOT. And it is unfair and highly divisive for the this Council to cave-in to the desire of the developer to have his development given what will be, in effect, like a Good Housekeeping Seal of Approval signed by the members of the elected councilwomen and councilmen of our fair city. 
