Reno is my hometown. I was born and raised here and my family remain active community members. This city is where I discovered I had talent as a performing artist. This city provided me with opportunities to develop and grow that talent before sending me out into the world. Life took me on an adventurous journey to theatrical institutions across the country, ranging from huge musicals on Broadway to tiny summer stock theatres in the Midwest, but Reno remained one of my most important artistic homes. For 25 years, I prioritized returning to the area to teach and create for local dance studios, commercial theatre producers, and other area institutions. I offered children coaching in dance technique, scholarship opportunities, and advisement on higher education. I gave industry talks to the students of Damonte Ranch, McQueen, North Valleys and ICDA high schools. I was commissioned for three guest artist residencies in the University of Nevada Reno Department of Theatre and Dance where I created concert ballets and two large scale, sold-out musicals that served as a catalyst for the creation of the musical theatre program. I continued to mentor many UNR graduates in the field. I have worked for local producers, including Mark & Jinger Kalin and Karen Burns, and maintain associations with local creators at Reno Little Theater and Sierra School of Performing Arts, among others. In 2014, I was honored to receive an award from the Reno City Council proclaiming "Adam Cates Day" in recognition of my contribution to the arts scene. My roots in this community remained deep, even while residing in New York City for two decades. Then in 2020, life changed. The pandemic shutdown devastated performing arts communities nationwide and put my own career as an artist on hold, as well as my spouse, Steve, who works as a musician and musical director. In September 2020, we packed up a U-Haul and headed "home." As a full-time Reno resident once again, I am proud to help the performing arts community rebuild. In a position created for me at the Pioneer Center for the Performing Arts, I now have the opportunity to enhance arts education for our region's school children while helping guide the growth of this foundational institution. I am inspired to give back to the arts community-at-large in Reno, as the arts affect the quality of life and well-being of everyone who lives here. This is why I want to serve on the Reno Arts and Culture Commission. With over two decades of arts work experience in communities and venues across the country, I have had a front row seat to study a variety of approaches to nurturing and supporting the arts. I take great pride in the work this Commission and other organizations have undertaken in the last decade to reimagine the artistic fiber of this city. I want to be a part of continuing and developing that legacy, not only for local artists of all backgrounds and mediums to thrive here, but so that the community can benefit, learn, and continue to be inspired, entertained, and included.
