Your Comment	To the Reno City Council:

As a nearby homeowner to the area being considered during this Public Hearing (LDC21-00034 -Canyon's Edge) and resident of the city of Reno, we are opposed to the plan being currently considered to amend the land use designation for LDC21-00034. Support for this position is summarized below.

1) Additional development in this sensitive area has long-term, irreversible consequences. The destruction of the natural environment at this location adversely impacts wildlife, horses, and alters water pathways and land management. As you are probably well aware, this is the pathway that the wild horses of Nevada use for food and water. It is also used by other natural wildlife in this region.

2) Additional development in this area impacts the availability of water for residential use which is already a limited resource. The additional traffic in the area is likely to increase considerably, adding stress to this sensitive area and to the issues identified above (1).

3) Importantly, this plan to amend the land use does little to address the housing crisis in the greater Reno area. We hope that the Council would require measures to address this issue as you consider whether to allow this development to proceed. Please consider whether this amendment best meets the needs of all residents of Reno and please ensure that the decisions made address in one form or another, the housing and water shortage for the Reno residents.
