My name is David Spring. I am a 49 year old disabled, autistic veteran of the first Gulf War in the mid-90's. These days I live with my two tween-age children in VASHUD housing while I attempt to recover from several severe

medical conditions. My income is roughly \$550 a month.

Although I have recently discovered there is a new program offered by both Lyft and Uber to help me get to medical appointments for free, this really

doesn't help with all of the other issues I am about to mention.

Over the past three years I have had to pay hundreds of dollars in late fees, missed several job interviews and very important medical appointments, and been forced to walk for hours in severe weather due to the absolute and complete incompetence of RTC.

I have been yelled at, threatened, and injured by multiple drivers as well as watched others suffer the same abuse with no consequences for any staff. And now I have come to find the company ruining our public shared

resource for private profit used to transport Jews to Nazi death camps during

WWII under the name "SNCF".

Since I know I am not the only one suffering from this dilemma, I have

questions.

When do I and thousands of others get to go back to work? Jobs require "reliable transportation". I cannot afford a vehicle until I find a decent job. No job within walking distance of my housing pays enough to even cover the absurdly rising rent in this city.

How are others supposed to get to life saving medical appointments? I have personally missed roughly a half a dozen over the past few years, and now am apparently suffering more severe heart issues directly related to missing those appointments. There is no way I'm the only one in this city with this problem.

Does the mayor realize a city with this small of a population cannot support a privately operated public transit system? It's basic math. Public tax money should ROBUSTLY fund public transportation at an immediate loss. The profits for the city come back in the various forms of tax revenue generated from higher employment, more public access to businesses, and increased tourism as the city becomes more desirable again.

And on that last note, why are we relying on a company who has never reconciled with their past atrocities? They helped the Nazis murder untold numbers of Jews during WWII. Why would anyone do business with them at all?

Why do they seem to be hiring the meanest and most incompetent folks they can find and refusing to train them properly? Is it just cheaper to find abusive, terrible drivers?

If we vote in a new mayor in the next election, may we fire Keolis and regain control of our city so our businesses might thrive again and folks can go back to work and actually make plans for their lives again? Public transportation is the circulatory system of any city. Keolis is heart disease. Why is Reno being asked to foot the bill for Keolis' part in a genocidal war at a total loss to our economy and employment percentages? I appreciate any response I receive.

While I am in favor of the expedited attention Council is giving to a plan and timeline for filling the ward 5 vacancy, I am writing to express my strong preference for a special election as the method to be used. I am sure that there will be a case to be made for Council to appoint someone to the vacancy. I can think of three factors in favor of this:

1. expense.

2. representative democracy - that Council has been elected to make certain decisions on behalf of the majority who voted for them.

3. time - better to get someone in place ASAP

I mention these three factors in an attempt to demonstrate that I can see both sides of your decision. That said, I would like to explain why (especially at this time), I think it would be preferable to hold a special election:

a) Ward 5 voters vote for their Council member. If Council appoints someone, there will be four Council members (for wards 1 through 4 inclusive) choosing the new member for ward 5. Ward 5 voters did not elect the Council members for wards 1-4 and yet this decision may be decided by them for ward 5 voters if Council chooses to appoint a replacement.

b) In terms of time, if you look back to the special election of Council

Member Reese, there were well over 100 candidates that had to be whittled down to 4. Those 4 presented their case for their selection in a public meeting. While an election will no doubt take longer, this process is not an inconsiderable one in terms of time. Moreover, is offering the ward 5 voters the chance to hear only 4 candidates and ask questions of them enough of an opportunity to learn what kind of Council member the voters would be getting? I would contend that a great deal more time is needed; that amount of time is afforded by a special election.

- c) From my personal experience, regarding two important parts of ward 5, Downtown and Verdi, in the last year there has been a significant amount of discontent with both the practices of and decisions made at Council. As examples I would offer: the Neon Line District (in particular, the development agreement), and the change of the dwelling cap for the Meridian 120 development. Considering this, I feel Council would send a strong message of openness and consideration for the ward 5 voters by holding a special election.
- d) While I won't debate the fact that a special election will cost more than an appointment, I will still argue that the election is the democratically right thing to do. Democracy is under attack in the US as a whole and in Nevada as well. A judge just denied a candidate for Governor his appeal against a fairly executed election. Nye County has just appointed (appointed, not elected) an election official who is unwisely switching to paper ballot counting and denies the result of the 2020 presidential election. I respectfully ask the Council to stand up for democracy in Reno; let the ward 5 voters actually vote directly for their Council member in a special election.

Finally, I am very concerned that many of the voters in ward 5 are not aware of Friday's special Council meeting. The announcement that Vice Mayor Jardon was stepping down just became public on Tuesday! Many people can't leave work to attend the special meeting in person. I have been trying to get the word out, but I truly don't feel there has been sufficient time for ward 5 voters to get organized. On Friday, I therefore doubt that Council will get a true reflection of the ward 5 voters preferences on the method to fill the vacancy.
