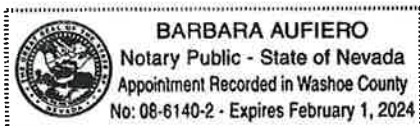

Dear City Council Members-

I'm a longtime Reno and Ward 5 resident. I attended school here (Hug 1972, University of Nevada 1979). I married my wife of 42 years and together we raised three kids who have chosen to stay in Reno, where they live and work. In 1983 I bought a business that I owned and operated for 34 years until I sold it and retired 5 years ago (my wife retired as a Washoe County school teacher 4 years ago). During the time we were raising our family we were deeply involved in the kids academics and activities as many of us were. I coached and served on the board of Reno American Little League and Reno West Babe Ruth for 10 years, coached Y basketball for 8 years, instructed in the Jr. Ski Program for 5 years and we enjoyed the full array of outdoor activities that this area affords. Reno has been extraordinary good to my family. I couldn't be more grateful.

Over the years and decades we've seen our city grow into a legitimate metropolitan center and hub of business growth but with the growing pains and challenges associated with that growth along with outside influences. Homelessness, housing affordability, traffic, how we define our downtown, how we embrace our river corridor, how we balance landowner rights with the public good as it relates to historic buildings, how we approach beautification and cultural projects, how we maintain, enhance and expand our public spaces, how we get in front of our infrastructure needs associated with growth and also with obsolescence, how we approach issues related to climate change such as flooding and water availability, how we fund our solutions in a fair and equitable way. My story and perspective is not unique but it is genuine and I believe I have a lot to contribute to the Reno City Council over the next two-plus years.
