-Currently in my fourth home in N/W Reno. Reside at 8764 Lynrock Cir in Somersett having downsized from another Somersett home three years ago.

-Retired this year from a consultant job with New York Life where I was required to do a great deal of public speaking. I'm 64 years old.

-Education: Political science degree from Xavier University in Cincinnati Ohio.

-Work experience. Relocating to Reno from Cincinnati in 1979 I initially worked as a dealer in the casinos. For those that may remember them I broke in at the Money Tree and worked at Mister C's and the Flamingo Hilton as well. In 1984 I started work in the insurance business for Transamerica. I worked with the Varney Padgett agency in Sparks until 1999 when I went to New York Life as a manager. With NYL I worked as a manager up until 2007 when I became a consultant working in multiple offices in the Pacific zone and covering 600 agents in my specific territory.

I've watched Reno change a great deal since I've been here. When I arrived McCarran Blvd, meant to ring the city, was not yet completed. I found the idea of a McCarran Blvd both unique and creative. With the McCarran ring long since finished I spend some evenings riding my motorcycle the length of it to reminisce. Quite pleasant. Unfortunately, a ride along Virginia street downtown doesn't have the same feel. What used to be a vibrant active place is now to a degree blighted and somewhat inhospitable to tourists.

I watched years ago as the city worked on revitalization, a worthy cause of course, but I found myself wondering why we started with the area just beyond the casinos. Though now that area is a much nicer place to live and work it's the casinos that bring new money into Reno. I never understood why we didn't start with the casino areas first. I believe the mindset that was started then has something to do with Reno being stuck with an eyesore where the memory-creating Harrah's once thrived.

Politically and fiscally I lean conservative though I'm quite liberal on many social issues. I see myself as balanced for several reasons. Though well-educated I also have street smarts. I often tell people that casinos are laboratories of human emotion. Working in them gave me a unique insight into what makes people tick.
