Ward 5 Constituent Submitted Questions

Will you push funding surrounding Sierra Vista Park? What improvements will you bring to Northwest Reno?

1) REGARDING PEDESTRIAN SAFETY: A 2022 analysis by a national insurer found that Reno is among the most dangerous cities in the nation for pedestrians, based on 4.6 million car insurance applications, and focusing on cases where drivers failed to yield to people walking on the street and were cited. From personal, anecdotal experience, Downtown feels more pedestrian-dangerous than just a few years ago. As our ward 5 council member, what would you do to make our streets safer for pedestrians?

2) REGARDING THE DOWNTOWN RENO PARTNERSHIP: Former Ward 5 Council Member Jardon was the City Council's liaison to the DRP. You may therefore inherit that role. Looking at the DRP board membership, I see two resident representatives and fourteen other representatives of special interest groups such as: Commercial Realtors, multiple casinos, several developers, several health industry executives, and a UNR executive for real estate. Given this powerful group, as the Ward 5 representative, what would you do to ensure the best interests of Downtown RESIDENTS are given equal weight?

Do you think this process resulted in the best and most qualified applicants being selected as finalists?

very biased towards the more affluent population in Somersett to the disadvantage of those in the Old Northwest, which had its own advisory board taken away by the city.

2 - How will you assure Ward 5 residents that you will keep their interests and the city's interests a priority over the interests of campaign funders , especially developers?

What are your thoughts regarding the City of Reno Master Plan for Development Growth Tiers and the reality of developers requesting development of land that is not a priority Growth Tier?

In yesterday's meeting, all three candidates discussed the need for more housing. What could the council do to actually address that issue? Would changing zoning to allow higher density such as ADU's and duplexes be one part of an approach?

The City budget is \$915m and has professional to manage the day to day. The council provides oversight. Can you please explain your experience either managing or providing oversight of large budgets.

How can the City hold developers better accountable? Specifically, how to incentivize Jacob's to improve on all the vacant lots they created, and how can the City prevent that from happening again with another developer.

Have you been specifically active in Ward 5 activities such as our Neighborhood Advisory Board and what have you learned about our needs from those activities?

Why would it be appropriate to appoint someone with so little life experience who is so unfamiliar with Reno that he does not know the correct way to spell Traner Middle School? I am referring to Elliot Malin.

Why is it appropriate to appoint a political operative of the Democratic Party who has lived in Reno for less than five years and was rejected at the ballot box by his own Democratic voters - many in Ward 5 - two months ago? I am referring to Alex Goff.
