#### **Background:**

Pursuant to RMC 2.08.770 - 2.08.780, the RACC consists of 11 members who are registered voters and reside in the Truckee Meadows area, a majority of whom shall reside and be registered voters in the City of Reno. The commission is to consist of at least one architect or designer, one arts educator, and one professional artist. The remaining members shall represent business and the community at large.

Members of the RACC are appointed to terms of three years and each commission member may serve a maximum of two consecutive terms.

## Method of Appointment:

Members shall be appointed by Council as a whole. The Arts and Culture Commissioners provide a recommendation for appointments.

## **Financial Implications:**

Legal review completed for compliance with City procedures and Nevada law.
