#### **Summary:**

Jenifer Rose and Jessica Sferrazza's terms on the Reno-Tahoe Airport Authority (RTAA) are due to expire on June 30, 2023; Members Rose and Sferrazza have served two full terms on the Authority and are ineligible for reappointment.

The term of appointment is for the period July 1, 2023 to June 30, 2027.

# **Background:**

The Reno-Tahoe Airport Authority Act, adopted in 1977, is codified as Chapter 474, Statutes of Nevada 1977, and is a special act. Sec. 5 of the Act, as amended, requires that the City of Reno be represented on the Board by four trustees, the City of Sparks by two trustees, and Washoe County by two trustees. In addition, the County Fair and Recreation Board appoints one

trustee. A term is for four years, with a limit of two terms. Appointees must have: (1) experience in aviation, business or tourism, or (2) experience in finance or accounting or possess other qualifications that the appointing authority determines are necessary or appropriate for carrying out the duties of the board. An appointment of a member of the Board of Trustees must be made not later than June 15 of the year in which the member is required to be appointed.
