#### **Summary:**

On April 12, 2023, Council accepted the Gehl Virginia Placemaking Study and phased implementation plan. Staff was directed to pursue phase one of the implementation plan including streetscape furnishing zones, Locomotion Plaza 2.0, and the ROW Placita, and the Façade Improvement Program and to bring an update to Council on options for the use of the ARPA funding allocated by Council on March 8, 2023.

The Placemaking Study recommended that that the actions for prioritization take place in three phases. The first phase of projects will require an agreement with an Urban Designer. City staff anticipates the scope to include management and coordination of design, landscape, survey, and specialty design services such as geotechnical, structural and electrical. This agreement will provide 100 percent design for streetscape furnishing zones, Locomotion Plaza 2.0, and the ROW Placita.

# Phase 1 – Areas 1, 3 & 4 Streetscape/Locomotion Plaza/Placita



Staff recommends Council authorize the City Manager to sign a consultant agreement for an Urban Design Firm to bring the Phase One recommendation to 100 percent design.

## Alignment with Strategic Plan:

Economic and Community Development Infrastructure, and Environmental Sustainability

## **Previous Council Action**:

April 12, 2023 – Council accepted the recommendations of the Virginia Street Urban Placemaking Study, including the Phased Implementation Plan, directing staff to develop cost estimates and return to Council with an update on Phase One of Implementation.

March 8, 2023 – Council approved the allocation of the remaining \$28,150,044.97 in State and Local Fiscal Recovery Funds received through the American Rescue Plan Act on May 19, 2021, including possible allocation to specific projects identified through the public, Council, and staff engagement process or general spending categories identified by Council as a priority for fund allocation by December 31, 2024.

February 23, 2022 - Council approved to finalize and enter into a Professional Services Agreement with Gehl Studio to complete a Virginia Street Urban Placemaking Study in an amount not to exceed \$150,000. (Regional Transportation Commission reimbursement and Street Fund)

September 8, 2021 - Council approved an Interlocal Cooperative Agreement with the Regional

Transportation Commission (RTC) of Washoe County to complete a Virginia Street Urban Placemaking Study in an amount not to exceed \$150,000 with the RTC agreeing to reimburse the City of Reno 50 percent of the costs, in an amount not to exceed \$75,000. (Street Fund)

## **Background:**

Council has approved for \$3,000,000 for Placemaking in State and Local Fiscal Recovery Funds to help begin implementation of recommendations from the Virginia Street Urban Placemaking Study. \$1,000,000 for the Re-Store Façade and Tenant Improvement Program and \$2,000,000 for other Placemaking efforts on Virginia Street. With Council's acceptance of the Gehl final report, city staff was directed to create design and cost estimates for each project based on the recommendations set forth by the Placemaking study. As projects are developed in detail, they are being brought back to Council for approval.

#### **Discussion:**

Gehl recommended that Implementation be executed in three phases. Each phase has actions and staff is developing action plan steps to implement each phase, starting with phase one.

#### **Phase One Actions:**

- Streetscape furnishing zones
- Locomotion Plaza 2.0
- The ROW Placita
- The Façade Improvement Program.

#### Phase Two Actions:

- Streetscape improvements across the site
  - o Signal timing, street parking and pick-up/drop-off, bike facilities
- Believe Plaza 3.0 Initiation

#### Phase Three Actions:

- Streetscape improvements upper area
  - o Improvements with the buses and freeway overpasses
- Maker Row @Court edge activation in the lower area
- Believe Plaza Capital Improvements

The next step for the Phase One action plan requires a consultant agreement for Urban Design services to bring Streetscape furnishings, Locomotion Plaza 2.0, and The Row Placita to 100% design.
