Summary:

On November 21, 2022, the Reno Arts & Culture Commission (RACC) reviewed the Grant Committee of the Reno Arts and Culture Commission's ranking and scoring of 22 Arts and Culture Project Grant applications for 2023. The RACC recommended funding of 14 Arts and Culture Project Grants based on scoring in the amount of \$76,265. Staff recommends Council adoption of a Resolution and approval of the Agreements to allocate \$76,265 to 14 nonprofit arts and culture organizations for purposes described below.

Alignment with Strategic Plan:

Arts, Parks, and Historical Resources

Previous Council Action:

There is no recent Council action relevant to this item.

Background:

The Grants Committee of the Reno Arts and Culture Commission met November 15, 2022 to score and rank 22 Arts and Culture Project Grant applications. Projects, community festivals, special performances, exhibitions and other events may benefit all area residents, but must be of definable benefit to Reno residents. A performance, exhibit or other activity must take place within the City of Reno's city limits. If a project involves activities in a variety of areas, the portion taking place in Reno, or of primary benefit to Reno residents, will be the portion eligible for consideration. A 1:1 cash match of requested grant funds is required.

- \$5,600 to Note-Able Music Therapy Services for Community-Based Music Programs to Enhance Inclusion of People with Disabilities
- \$5,723 to Pioneer Center for the Performing Arts for Pioneer Center Youth Programs
- \$5,898 to Reno Bike Project on behalf of KWNK Community Radio for Community Voices Series
- \$5,635 to Reno Chamber Orchestra for Reno Chamber Orchestra/Northern Nevada HOPES partnership
- \$5,320 to Reno Jazz Orchestra for RJO Mentor Program & After School Program
- \$5,425 to Reno Little Theater for RLT 2023 Education Program
- \$5,320 to Reno Philharmonic Association for Reno Philharmonic Association Kids (RPAK) Spring Semester
- \$5,390 to Sierra Nevada Ballet for SNB Reno Season Ticketed Productions 2023

Each organization will sign an individual Agreement and an Affirmation of nonprofit status for the project. Copies of the standard agreements are attached. The University of Nevada Reno's agreement includes slightly different language in a few sections to address their status as a State Agency and to disallow expenses such as staff salaries and facility charges. The City Attorney's Office has approved the agreements and affirmation.

Discussion:

This is an annual grants program undertaken by the RACC on behalf of the City. On November 21, 2022, the RACC reviewed the recommendation of the Grants Committee which had reviewed 22 grant requests. The 8 grants that scored below 70% were not recommended for funding.

These Project Grants provide funding for organizations to produce programming with a focus on Arts Access and Youth. Three years ago, the RACC initiated diversity, equity, and inclusion (DEI) requirements into their grants in order to reach a larger constituent base by encouraging partnerships, innovative programming, and attracting new groups to apply. This initial push for DEI requirements was accompanied with workshops for grantees and applicants led by an outside facilitator to help organizations implement DEI intiatives into their programming. The RACC continued to add DEI requirements over the last few years and, this year, added requirements for accessibility.

Financial Implications:

The Arts and Culture Project Grants in the amount of \$76,265 are included in the FY22/23 budget. The entire amount comes from the Room Tax allocation to the Reno Arts & Culture Commission. Grant agreements state they are subject to final Council approval of the agreement and contain a Funding Out paragraph to provide additional financial flexibility to the City.

Legal Implications:

Legal review completed for compliance with City procedures and Nevada law. NRS 268.028(1) states the governing body of a city or its authorized representative may make grants by resolution to non-profit organizations created for religious, charitable or educational purposes, to be used for any purpose which will provide a substantial benefit to the inhabitants of the city.

Recommendation:

Staff recommends Council adopt the Resolution.
