Carter Williams, City of Reno Development Services Associate Planner, answered questions from Council regarding the PUD.

Council Member Brekhus discussed concerns she has heard regarding horse and human contact, particularly wild horses and cars. She asked what the road length increase is.

Brooklyn Oswald, Aryte Group LLC on behalf of the applicant, confirmed that information is included in the fiscal impact analysis. He does not have an exact number but it is roughly a third to a half more roadway.

Mr. Williams summarized for Council Member Ebert the changes regarding wild horses.

Council Member Brekhus stated they are looking at 30% more roadway with 40% more homes. She discussed her reasons for not supporting this. Those reasons are related to putting more people in a fire risk area, more roadway with potential for carnage with horses, and more road maintenance required. She also noted that she does not find it compelling that the applicant will follow through at time of construction. It is unfair to represent that certain people will be involved in the project going forward. She also asked staff to make sure they have the PUD certifications up on the website.

Council Member Ebert noted that Vice Mayor Duerr mentioned there was a verbal agreement made with the applicant after the last meeting on this item. She stressed how important it is that those things are in writing as there is no guarantee it will happen.

Vice Mayor Duerr stated this is a very difficult project for her and she wants to make sure that previous commitments that were made by other Dolan family members are continued. She asked a Wild Horse Connection representative to state on the record what was said between them and Mr. Dolan.

Deana Kirk, Wild Horse Connection, stated they did have a good conversation after the last meeting about the way things should be. Mr. Dolan said they need to sit down and be open to having these conversations and not wait until they are in these meetings to argue about it. They agreed to be in communication throughout the entirety of the project and to also have follow through. She stated that Mr. Dolan was quite kind and really wanted to do whatever he could and he wanted to know what they needed. Communication and follow through are key and that is what they talked about.

Vice Mayor Duerr noted that there are a number of issues that will be addressed at the tentative map phase.

Discussion on the motion:

Council Member Ebert will not support the motion because there should be more things ironed out. It is not because she does not think everybody's hearts are in the right place, but we should have more things in writing for this project.

Discussion after the vote:

Vice Mayor Duerr stated they are counting on the technical team to do the right thing and make this as good a project as they possibly can, and get the people up to speed with what has been committed to and the history of this project.

Jackie Bryant, City of Reno Interim City Manager, stated that the certified Canyons PUD is on the Reno.gov website under Development Services.
